Vendor shall not be considered in default if delay in delivery occurs due to causes beyond his control such as acts of God, natural calamities, civil wa rs, fire, strike, frost, floods, riot and acts of unsurpassed power. Only thos e causes which have duration of more than seven (7) days shall be consid ered cause of force /calendar majeure. A notification to this effect duly cer tified by the statutory authorities shall be given by the Vendor to the Own er within 10 days from the date of such Force Majeure condition by regist ered letter. In the event of delay due to such causes, the delivery schedul e will be extended for a length of time equal to the period of force majeur e or at the option of the Owner the order may be cancelled. CANCELLATION/ SHORT CLOSURE:

The Owner may terminate/short close the contract, by not less than 30 days' written notice to the bidder, to be given after occurrence any of t he events specified in the SI. No. (a) to (e) of this clause and 60 days in the case of the event referred to SI. No. (f), (g) & (h) below:

- The Vendor fails to comply with any of the terms of the Order or the bi dder do not remedy a failure in the performance of their obligations un der the Contract, within thirty (30) days after being notified or within a ny further period as the Owner may have subsequently approved in wri ting.
- The Vendor becomes bankrupt or goes into liquidation.
- If as a result of Force Majeure, the Bidder is unable to supply a materia I for a period of not less than 60 days.
- If the Bidder, in the judgment of the Owner has engaged in corrupt or f raudulent practices in competing or in executing the Contract. For the purpose of this clause.
- "Corrupt Practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the selection process or in contract execution.
- "Fraudulent Practice" means a misrepresentation of facts in order to in fluence a selection process or the execution of a contract to the detrim ent of the Owner.
- The vendor is otherwise precluded from complying with any of the ter ms of the order on account of any directives of any lawful authority.
- If the Owner, at its sole discretion, decides to terminate this Contract.

DVC reserves the right not to issue/accept tender documents to any int ending bidders with whom DVC has stopped entering into business by virtue of policy decision

AGREEMENT:

Contracts shall be executed after receipt and verification of the requisite perfor mance security (wherever applicable). The said agreement will be duly signed b y the authorised representative of DVC (TIA/ Signing authority as per DFP) and a uthorised signatory of Supplier/Contractor/ Service Provider/Consultant. Within 7 days from the date of issue of LOA/PO/Work Order, DVC will send the agreement (wherever applicable) to the Supplier for signature, incorporating all agreements between the parties for execution.

The Supplier/Contractor/ Service Provider/Consultant should acknowledge and u nconditionally accept, sign, date and return the agreement within 14 days from the date of issue of LOA/PO/Work Order. If both parties simultaneously sign the c ontract across the table, further acknowledgement from the supplier is not required.

Non- execution of Contract Agreement by the Supplier/Contractor/Service Provid er within 45 days from the date of issue of LOA/PO/Work Order, due to the fault of the Supplier/Contractor/Service Provider, will constitute sufficient ground for f orfeiture of its EMD (wherever applicable) and shall short close the Contract and retender and in this re-tender such defaulting Bidder will not be allowed to parti cipate.

A contract document should be executed, with all necessary clauses to make it a self-contained contract. If, however, these are preceded by Invitation to Tende r, accompanied by GCC and SCC, with full details of scope and specifications a si mple one-page contract can be entered into by attaching copies of the GCC and SCC, and details of scope and specifications, offer of the tenderer and letter of a ward.
