# Commodity EXIM Report DGCI & S, I T J Division

The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns w.r.t. selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for better policy making.

2. For both categories of trades, one commodity group is chosen from the entire ITC-HS 4-digit Classification (latest being 2023-2024 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C & I Database, global export-import data of exactly those sets of commodities are sourced from UN-COMTRDADE Database.

3. As regards the time-period, this report outlines trade statistics over a period of four years. Currently (for reports being prepared in FY 2023- 2024) we are considering the time-period of 2020-2021 to 2023-2024 (Financial year data). The latest finalized data available on the UN Comtrade Database is only up to year 2023 (Calendar Year) and on the DGCI&S Database up to June, 2024. So, for each commodity group dealt in this report, trends from 2020 to 2023 have been showcased where data has been sourced from UN Comtrade and from 2020-2021 to 2023-2024 when sourced from DGCI&S database; however, for computation of commodity group's share in India's overall export basket and import basket we have had to use FY (financial year) data as all aggregate level data in India are represented in FY format.

4. In the instant report [5<sup>th</sup> weekly Commodity Exim Report of July,2024 dated 31st July, 2024] the following two commodities have been dealt with.

**Export : Unmanufactured Tobacco. [ITCHS Code –2401]** -In FY 2023-2024 (April,2023 –March,2024) this commodity group has 0.24% share in India's total Export value basket as per DGCI&S data base. As per UN Comtrade database India had occupied the 4<sup>th</sup> slot in export of this commodity (968.67 million USD) with 9.33% share of total global exports in the year 2023.

**Import : Copper Ores and Concentrates [ ITCHS Code – 2603 ]** –In FY 2023-24 (April 2023 – March,2024) this commodity group had share of 0.46% in India's total Import value basket as per DGCI&S data base. India having 3.34% share of total global imports of this commodity (3057.89 million USD) occupied the 5<sup>th</sup> slot in the world in 2023.

## **EXPORT**

**Unmanufactured Tobacco** classified as H.S. Code – 2401 falls under Chapter -24 (Tobacco and Manufactured Tobacco Substitutes) of Section IV (Prepared Foodstuffs Beverages and Tobacco) of ITC-HS classification. India is engaged in the process of exporting this commodity and in 2023-2024 FY this commodity group has so far had 0.24% share in India's total Export value basket as per DGCI&S data base.



India's top 10 destinations of Unmanufactured Tobacco by percentage share in 2023-2024



The total value of exports of Unmanufactured Tobacco from India amounted to US\$ 1052.04 million in 2023-2024 and registered an increase of 27.95% compared to 2022 figures of US \$ 822.23 million. For, the period under review, exports in this segment were at US\$ 517.54 million in 2020-2021 followed by a moderate rise till 2023-2024. Belgium (US\$ 269.21 million) has held the top slot as an export destination in this segment from India with 25.59% share of India's total export. In second and Third place were UAE (US\$145.97 million ) and Indonesia (US \$ 87.42 million ) to where India exported 13.88% and 8.31% share of its total export of Unmanufactured Tobacco respectively in 2023-2024.




 World's Top 10 exporters of Unmanufactured Tobacco (ITCHS Code - 2401)

World's 10 leading exporters of Unmanufactured Tobacco (percentage share in 2023):




The global export of Unmanufactured Tobacco reached US \$ 10382.24 million in 2023, increasing by 2.62% over the previous year. The lead exporter in this segment has consistently been Brazil (exporting goods worth a total of US\$ 2543.78 million) with a show of 24.50% share in 2023. Zimbabwe (US\$ 1190.96 million) and USA (US\$1003.61 million) with 11.47% and 9.67% share of world export in this segment in 2023 stood at 2<sup>nd</sup> and 3<sup>rd</sup> slot respectively. **India** (exporting goods worth a total of US\$ 968.37 million in this category) with a show of 9.33% share, stood at 4<sup>th</sup> slot in 2023 of world export of Unmanufactured Tobacco. India's export value in this segment had continuously increasing from 2020 till 2023.



Top 10 importers of Unmanufactured Tobacco from 2020 to 2023 Data labels signified for 2023




World's 10 leading importers of Unmanufactured Tobacco percentage share in 2023




The Unmanufactured Tobacco imports worldwide was US\$ 8301.83 million in 2023, decreasing by 13.72% from 2022 levels. The lead importers in this segment in 2023 have been China (20.42%), Germany (12.88%) and Poland (9.55%). **India** with a show of only 0.23% share in this category, stood at 47<sup>th</sup> position globally. Global imports in this segment had increased in 2021 compared to the year 2020 and then declined till 2023 with major dip in 2023. A difference is observed between global exports and global imports of this segment as per UN Comtrade statistics. In 2023 global exports exceeded global imports by US\$ 2080.41 million.

As per UN Comtrade database the to 3 importers of Unmanufactured Tobacco were China, Germany and Poland. Out of these three country **Germany and Poland** had imported 8.42% and 9.72% share of their total import of this commodity from India in 2023 which are presented below :

### **IMPORT**

Copper Ores and Concentrates as ITCHS Code -2603 falls under Chapter -26 (Ores, slag and ash ) of Section - V (Mineral Products ) of ITC-HS Classification.

India is engaged in the process of importing this commodity and in the FY 2023-2024 this commodity group had share of 0.46% in India's total Import value basket as per DGCI&S data base.

In 2023-2024 India had imported a total of USD 3133.22 million worth of Copper Ores and Concentrates, decreasing by 8.13% compare to the year 2022-2023. As per available data, Indonesia stood out as India's top importing partner in this segment with a share of 35.41%. Next in line comes Chile and Australia with shares of 21.49% and 9.64% respectively. India's import value in this segment has been steadily increasing from US\$ 796.63 million in 2020-2021 to US\$ 3008.67 million in 2022-2023 with a major leap in 2021-2022 and then a dip in 2023-2024.

Worldwide import of Copper Ores and Concentrates totalled to US\$ 91512.37 million in 2023 recording a declined by 6.06% over 2022 levels. China imported US\$ 59941.38 million worth of the commodity in 2023, making it the leading importer of the commodity group worldwide with 65.50% share of world imports. Japan (12.83%) and Germany (3.61%) lined up in second and third place in 2023. The import value of Copper Ores and Concentrates in **India** amounted to approximately US \$ 3057.89 million in the year 2023 and **India** ranked 5<sup>th</sup> in the world with the share of 3.34% of total global import value of goods in this segment experiencing a moderate leap from 2020 till 2023.
