2. Delivery Schedule

Time for completion of both the jigs including commissioning & proving of the jig is 1 0 months from date of Purchase Order.

3. Payment Terms:

First Milestone: On Delivery of Goods to BEML Ltd Bangalore Complex: 60 % Payment of the basic price of Goods along with 100 % GST in 10 days.

Second Milestone: on commission/Acceptance and Proving out Jigs Balance 40 % payment of the basic price of Goods on and generation of CRAC in GeM Portal.

Indian laws both substantive and procedural, for the time being in force including mo difications thereto, shall govern Contract. The competent Indian courts shall have sol e jurisdiction over disputes between purchaser and the Supplier

INTELLECTUAL PROPERTY RIGHTS; LICENSES

If any Patent design, trademark or any other intellectual property rights apply to the delivery or accompanying documentation, Purchaser shall be entitled to the legal use thereof free of charge by means of a non-exclusive, worldwide, perpetual license. All intellectual property rights that arise due to the execution of the delivery by the Supp lier and by its employees or third parties involved by the Supplier for performance of the agreement belong to Purchaser.

The Supplier shall be obligated to do everything necessary to obtain or establish the above mentioned rights. The Supplier guarantees that the delivery does not infringe on any of the intellectual property rights of third parties. The Supplier shall also be o bligated to do everything necessary to obtain or establish the alternate acceptable ar rangement pending resolution of any (alleged) claims by third parties. The Supplier s hall indemnify the Purchaser against any (alleged) claims by third parties in this regard and shall reimburse Purchaser for any damages suffered as a result thereof. The Supplier shall, as per agreed date/s but not later than the date of delivery, provide free of charge information and drawings which are necessary to permit the Purchaser to erect, commission, operate and maintain the product.
