Commodity EXIM Report for 1st week of February, 2026 dated 4th February, 2026

1. The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns with respect to selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for informed trade decision making.
2. For both categories of trades, one commodity group is chosen from the entire ITC-HS 4-digit Classification (latest being 2024 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C&I Database, global export-import data of exactly those sets of commodities are sourced from UN-COMTRADE Database.
3. As regards the time-period, this report outlines trade statistics over a period of four years, i.e., 2021 to 2024. The latest finalized data available on the UN Comtrade Database is only up to year 2024 (Calendar Year) and on the DGCI&S Database up to November, 2025. So, for each commodity group dealt in this report, trends from 2021 to 2024 have been showcased where data has been sourced from UN Comtrade and from DGCI&S database.
4. In the instant report [1st weekly Commodity Exim Report of February, 2026 dated 4th February, 2026] the following two commodities have been dealt with.

Export: Transmission shafts, incl. camshafts and crankshafts, and cranks etc. [ITCHS Code – 8483]

- In 2024 this commodity group had 0.48% share in India's total Export value basket as per DGCI&S database. India occupied the 8th slot in export of this commodity with (2080.03 million USD) 3.04% share of total global exports in the year 2024.

Import: Electrical Transformers, Static Converters (For Example, Rectifiers) And Inductors. [ITCHS Code – 8504]

- In 2024 this commodity group had 0.50% share in India's total Import value basket as per DGCI&S database. India (imports USD 3511.59 million) having 2.39 % share of total global imports of this commodity occupied 10th slot in 2024.

EXPORT

Transmission shafts, incl. camshafts and crankshafts, and cranks etc. classified as **ITCHS Code – 8483** which falls under Chapter -84 (Nuclear reactors, boilers, machinery and mechanical appliances; parts thereof) of Section XVI (Machinery and Mechanical Appliances; Electrical Equipment; Parts thereof; Sound Recorders and Reproducers, Television Image and Parts and Accessories of such Articles) of ITC-HS classification.

India is engaged in the process of exporting this commodity and in 2024 this commodity group had 0.48% share in India's total Export value basket as per DGCI&S database.



India's top 10 destinations of **Transmission shafts, incl. camshafts and crankshafts, and cranks etc.**
(ITCHS Code – 8483) by Percentage in 2024



In the year 2024 India exported Transmission shafts, incl. camshafts and crankshafts, and cranks etc. worth of USD 2112.77 million and increased from 2023 figures of USD 1979.73 million. USA (importing USD 1025.19 million worth of goods in this segment from India) held the top slot as an export destination in this segment with 48.52% share of India's total exports of Transmission shafts, incl. camshafts and crankshafts, and cranks etc. recorded for the year 2024. In second and third place were Germany (USD 209.04 million) and Italy (USD 110.60 million) to where India exported 9.89 % and 5.24 % share of total export of this commodity respectively in 2024. Over the period under review India's exports in this segment steadily increased till 2024 from 2021 levels.





The worldwide exports of Transmission shafts, incl. camshafts and crankshafts, and cranks etc. (ITCHS Code – 8483) amounted to USD 68518.34 million in 2024, decreased from the previous year figure of USD 69522.50 million. The lead Exporter in this segment has consistently been Germany (exporting goods worth a total of USD 13451.81million) with 19.63% share in 2024. China (exporting goods worth a total of USD 10400.95 million in this category) with 15.18% share, stood at 2nd slot in 2024 of world exports of Transmission shafts, incl. camshafts and crankshafts, and cranks etc. (ITCHS Code – 8483) followed by USA (USD 8895.62 million) with 12.98 % share of world export in this segment in 2024. India stood at 8th slot (USD 2080.03 million) with 3.04 % of global export of this commodity in 2024. World export in this segment increased till 2023 from 2021 level and then decreased in 2024 over 2023 level.





globally from 2021 to 2024 (Data labels signified for 2024)






The worldwide imports of Transmission shafts, incl. camshafts and crankshafts, and cranks etc. (ITCHS Code – 8483) was USD 68428.58 million in 2024, decreased from 2023 levels of USD 70776.70 million. Over the period under review (i.e. 2021-2024), global imports were at record high in 2023. The lead importers in this segment were USA (16.52%) in 2024 followed next by Germany (8.90%) and China (7.61%). **India** has 2.83 % share of world importing trade in this segment in 2024 and stood at 11th slot in the world. World import of Transmission shafts, incl. camshafts and crankshafts, and cranks etc. (ITCHS Code – 8483) increased till 2023 from 2021 levels and then decreased in 2024 over 2023 level.

As per UN Comtrade database the top 3 importers of Transmission shafts, incl. camshafts and crankshafts, and cranks etc. (ITCHS Code – 8483) globally were **USA, Germany and China**. These 3 countries imported respectively 10.42 %, 5.84 % and 1.47 % share of their total imports of Transmission shafts, incl. camshafts and crankshafts, and cranks etc. from India in 2024 which is presented below :



IMPORT

Electrical Transformers, Static Converters (For Example, Rectifiers) And Inductors classified as ITCHS Code – 8504 which falls under Chapter -85 (Electrical machinery and equipment and parts thereof; sound recorders and reproducers, television image and sound recorders and reproducers, and parts and accessories of such articles) and Section XVI (Machinery and Mechanical Appliances; Electrical Equipment; Parts thereof; Sound Recorders and Reproducers, Television Image and Parts and Accessories of such Articles) of ITC-HS classification.

India is engaged in the process of importing this commodity and in 2024 this commodity group had 0.50% share in India's total Import value basket as per DGCIS database.

The total amount of India's import of Electrical Transformers, Static Converters (For Example, Rectifiers) And Inductors. [ITCHS Code – 8504] in 2024 stood at USD 3564.32 million, increased from 2023 levels of USD 3118.21 million. Over the period under review, India's imports in this segment were at record high in 2024. In 2024, China stood out as India's top importing partner in this segment with a share of 55.21 % of India's total import in this segment followed next by Singapore (6.95%) and Hong Kong (6.04%). For, the period under review, India's imports in this segment increased till 2024 from 2021 levels.

Worldwide import of Electrical Transformers, Static Converters (For Example, Rectifiers) And Inductors. [ITCHS Code – 8504] was USD 147236.18 million in 2024, decreased from 2023 levels. Over the period under review, global imports were at record high at USD 154928.36 million in 2023. **India's** imports of this commodity amounted to approximately USD 3511.59 million in the year 2024 as per UN Comtrade database and **India** ranked 10th slot in the world with the share of 2.39 % of total global imports of this commodity. The top three Importers in this segment were USA (USD 29793.49 million) with 20.24% share of world imports in 2024, followed by Germany (USD 12139.73 million & 8.25 %) and China (USD 10175.40 million & 6.91%). Global import in this segment increased till 2023 from 2021 level and then decreased in 2024 over 2023 level.
