- A. <u>Technical Capability</u>
- 1) **Bidder must have registered office in Ranchi.** In case of not having a regi stered office in Ranchi, bidder will submit/produce an undertaking in this regard to start the office at Ranchi-within One month from the date of award of contrac t failing which the contract shall be cancelled and the EMD may be forfeited.

The Vehicles/Cars must be registered as Commercial vehicle and should posses s all the valid documents as per M.V. Act.

The registration of the Vehicles/Cars should not be more than five (05) years old from the date of issuance of NIT and should be well maintained and in roadwort hy condition.

4) Experience of bidder:
