If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 2. 3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM_No.1_4_2021_PPD_dated_18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. **PRICE BASIS:**

The Contract Price shall be FIRM & FIXED during the entire execution of the Contract and shall not be subject to any variation except on account of Statutory Variation on direct transaction between the Employer (DVC) & Bidder.

However, variation in the price of diesel during the currency of the contract shall be compensated / accounted for as per the following diesel price variation clause.

The contract rate to be quoted by the tenderer is subject to escalation due to statutory revision of price of diesel within the contract period as per the escalation formula given below:

In the event of price of diesel is increased or decreased by a competent authority after the date of opening of tender but during the period of contract including period of extension, if any, the formula given below shall be applicable and binding.

$$I = \frac{(D \times 2)}{d} \times \frac{(P1 - P0)}{c}$$

I = Increase or decrease in transport rate per MT.

D = Actual distance of the Mejia Thermal Power Station ash ponds to the designated disposal area.

d = Average run per litre of diesel by the vehicle which will be taken as 2.50 km.

P1= Price of diesel per litre on different date.

P0 = Price of diesel per litre on the date of opening the tender. (Techno-commercial Bid).

c = Average carrying capacity of a dumper / truck or Total weight in MT of ash evacuated in previous one month before the date of change in the price of diesel divided by number of corresponding trips of the dumpers/trucks during the same month.

NOTE: Diesel escalation/de-escalation will only be considered for vehicle (dumper / truck) engaged for ash transportation work. Working of no other machinery run on diesel like pay loaders/excavators/ dozer/generator, pumps etc. engaged for the work will be considered in the escalation and no claims/ disputes whatsoever shall be entertained /accepted.

2. **TAXES, LEVIES AND DUTIES** shall be as below:

(a) Except as otherwise specifically provided in the Contract, the Contractor shall bear and pay all

taxes, duties, levies, cess, etc. and charges assessed on the Contractor, its Subcontractors or their employees by all municipal, state or national government authorities in connection with the Facilities in and outside of the country where the Site is located.

(b) All taxes, duties, levies, royalties, fees, cess, etc in respect of the works and all other services to be done by the Contractor as per the NIT specifications and also taxes, duties, cess & levies as may be applicable on the materials used for the works shall be to the contractor's account & included in the Contract Price.

(c) The Contract price shall be inclusive of all taxes, duties, levies, royalty, cess, fees etc. including applicable GST, excluding applicable toll, if any. Toll, if any, will be reimbursable extra on production of documentary evidence of payment by the transporters to DVC.

GST @ 5% will be paid by DVC for ash transportation work & loading of Ash on FCM/R CM basis subject to issuance of consignment note by the transporters and 18% GST for other works in BOQ & toll if applicable, will be reimbursable extra on production of documentary evidence of payment by the transporters to DVC.

However, if DVC pays any taxes, duties, levies, cess, etc directly to the concerned statutory authorities, the same will be deducted from contractor's bill.

(d) Any changes in rate of GST and any new taxes, duties, levies, cess, etc. as imposed by statutory bodies after the last date of bid submission on the direct transactions between DVC and the Manufacturers/ Contractors/Service Providers /Suppliers will also be to the account of DVC as per rate ruling.

3. PAYMENT TERMS:

1. Payment shall be made after fulfilling all the following conditions by the Bidder:

(i) Acceptance of Letter of Award (LOA) and submission of an unconditional Bank Guarantee towards Performance Security in respect of the Contract as per clause no. (XI) of SCC of NIT.

(ii) Signing of the Contract Agreement.

2. The payment terms shall be as below:

(i) Ninety Five percent (95%) of contract price for works/service contract against RA bills with full GST (i.e. GST on total RA bill) at actual, subject to the limit as quoted for such item on certification by the concerned Engineer-in-Charge of DVC for the work done.

(ii) Remaining five percent (5%) of each running bill as retention amount at actual, subject to the limit as quoted for such item, on successful Completion of entire scope of work as per the Contract and its Certification by the concerned Engineer-in-Charge of DVC.

Note: The basis for the pro-rata payment for (i) above shall be done through BOQ on mutually discussed & agreed basis commensurate with sequential progress of work of the entire package.

4. VENDOR BILL TRACKING SYSTEM:

The Vendor Bill Tracking system is active & available at <https://application.dvc.gov.in/Vendor/> (under PROCEREMENT tab of DVC homepage <https://www.dvc.gov.in/>).

The Vendors on award of contract need to register themselves & submit their contract related bills online. After submission of the bill, a cover letter containing unique bill ID shall be generated which must be submitted to DVC along with other payment related documents in hardcopy.

5. SECURITY DEPOSIT-CUM-PERFORMANCE GUARANTEE:

To ensure due performance of the contract, the Supplier/Contractor/ Service Provider receiving the LOA/PO/Work Order is required to furnish the required performance security, in the prescribed form by the specified date. ["generally, 14 days after issuance of PO/LOA for Goods/Services Contract"] and it should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the contractor, including Defect Liability Period (DLP)/ warranty period, as applicable. Performance security should be for an amount equivalent to 3% (Three percent) of the ordered value

in one of the following forms
Ø Insurance Surety Bonds,
Ø e- Bank Guarantee
safeguarding DVC's interest in all respects

"Unconditional Bank Guarantee is to be as per the GeM format issued from any commercial bank in India (as per the list provided in Form10, VOL-VI of this NIT) and it should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the contractor, including Defect Liability Period (DLP)/ warranty period, as applicable [i.e the entire contract period (12 months) plus 60 days/ 02 months]. In case of delay in completion, the validity of this Bank Guarantee shall be extended by the period of such delay.

If the Contractor fails to submit the performance security within 30 days of the date of issuance of L/OA/PO/Work Order, DVC without prejudice to any other rights or remedies it may possess under the Contract, may forfeit the bid security (wherever applicable) and shall short close the Contract and re-tender and in this re-tender such defaulting Bidder will not be allowed to participate.

Performance Security shall be refunded to the contractor without interest, after he duly performs and completes all obligations under the contract but not later than a specified date ["365 days for Works Contract" or "60 days for Goods/Services Contract"] of completion of the Defect Liability Period (DLP) / warranty period, as applicable.

Before final payment or before release of the performance bank guarantee, a 'No Claim Certificate' must be submitted by the Supplier/Contractor/ Service Provider to prevent future claims. Also, an acknowledgement should be provided by the contractor after release of bank guarantee.

The performance security will be forfeited and credited to DVC's account in the event of a breach of contract by the contractor /Supplier/Service provider.

The BG/BG Ext. advice SFMS confirmation email from our Advising banks [PUNJAB NATIONAL BANK MANICKTALA, Kolkata, IFSC Code: PUNB0008220] will be obtained(if applicable).

Other terms & condition of Security Deposit-Cum-Performance Guarantee as notwithstanding in tender document shall be as per GTC & General Conditions of Contract (GCC) and Policy for withholding and Banning of Business Dealings of this NIT.

Bid Security/ Performance Security/ BG in the form of Electronic Bank Guarantee (eBG) from any Nationalized/ Scheduled Commercial Bank approved by Reserve Bank of India (RBI) will be accepted on immediate basis.

The customer/vendor is requested to take 'Input for Issuing eBG Form' provided in GeM ATC and approach the bank for issuing eBG.

6. VALIDITY OF CONTRACT:

Empanelment shall be valid for one year from the date of its formation.

7. COMPLETION PERIOD:

The period of execution for the individual Supply Order/ Work Order to be placed under the Rate Contract shall be ascertained on pro-rata basis in respect of Max. awarded contract value. However, completion period shall not exceed validity of the contract.

The Contract start date shall be notified to the Contractor and the Contractor shall mobilize their manpower, machineries etc. within 14(fourteen) days from the date of issuance of Work Order/ Supply Order.

"Completion of the Facilities" for the entire work under Supply Order (s) / Work Order (s) as per scope of work with BOQ & Technical specification shall be completed within the time allotted in Supply Order/Work Order from Start of Work date issued by the Power Station.

8. L.D CLAUSE:

-
- a) The Contractor shall commence work on the Facilities as per Letter of Award. The Contractor shall thereafter proceed with the Facilities in accordance with the time schedule specified in Time Schedule to the Contract Agreement.

As per GeM GTC- If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.

In cases, where the works/supply/services extend beyond the contractual completion schedule/delivery period and provisional extension order is issued without deciding on the application of LD, no amount from the RA bill will be deducted as "withheld LD" amount in case where adequate retention payment (over and above SD) remains with DVC as per terms of the contract.

- b) Alternatively, the Purchaser reserves the right to purchase / outsourced the material / spares / equipment / works / service from elsewhere at the sole risk and cost of the Vendor and recover all such extra cost incurred by the Purchaser in procuring the material/ works/service by the above procedure.
- c) Alternatively, the Purchaser may cancel the Order/contract completely or partly without prejudice to his right under the alternatives mentioned above.
- d) In the event of recourse to alternative (b) and (c) above, the Purchaser will have the right to re-purchase/ outsource the stores/works & service, to meet urgency in requirement caused by Vendor's failure to comply with the schedule of delivery/ completion of the work, irrespective of the fact whether the materials/equipment/works/service are similar or not.

9. PENALTY CLAUSE:

-

The rate of evacuation, transportation and disposal of ash not less than pro-rata W.O quantity per month should be maintained without fail subject to there is no hindrance in ash pond/disposal site or in the transportation route and favorable weather. In case of stoppage/slow progress of work, the shortfall should be compensated by providing additional men and machineries in the subsequent months. However, total ash evacuation, transportation and disposal of 100% of total W.O quantity should be completed by the time allotted in Work Order.

If the rate of evacuation of ash is less than pro-rata W.O quantity per month penalty will be imposed on less execution from the part of the agency.

Penalty for shortfall quantity on ash transportation shall be 5% of the transportation value per month on shortfall quantity with respect to quantity assigned to the transporter by the Engineer-in-charge, if the reason of the shortfall is attributable to the agency.

For example,

Say Cost of transportation (Rs. /Ton/Km) = X

Average distance of the slab = Y Km

Shortfall quantity per month = Z Ton

Then, Cost of transportation of shortfall quantity = Rs. X*Y*Z

So, Penalty = 5% of Rs. X*Y*Z.

10. SUB-LETTING & ASSIGNMENT:

12. CONTRACTOR'S PERFORMANCE EVALUATION SYSTEM:

-

In order to have smooth progress of the work, there is a need for contractors who will execute the job in time and as per stipulated specification quality in the Contract. In order to ensure the same a standard evaluation format has been framed & enclosed under 27(b) under OPTIONAL TERMS & CONDITIONS OF CONTRACT in GCC. The Engineer In charge will fill in the details as per above format, which is to be signed by the authorized representative of the Contractor (owner/proprietor/site in charge). If the contractor refuses to sign, the evaluation of engineer in charge will be final. The performance rating as emerged out will be kept in the system.

In case Performance Rating obtained above is 'Unsatisfactory', in a single contract in two consecutive billing cycles, the Contractor shall not be recommended for issue of tender enquiry for a period as deemed fit not more than 2 years.

13. INSURANCE:

The Contractor shall at his own expense take out and maintain in effect, or cause to be taken out and maintain in effect, during the performance of the Contract, the necessary insurance Policies.

14. AGREEMENT CLAUSE:

Contracts shall be executed as per format attached in Bid Forms & Procedures (BFP) after receipt and verification of the requisite performance security (wherever applicable). The said agreement will be duly signed by the authorised representative of DVC and authorised signatory of Supplier/Contractor/ Service Provider/Consultant.

Within 7 days from the date of issue of LOA/PO/Work Order, DVC will send the agreement to the Supplier/Contractor/ Service Provider/Consultant for signature, incorporating all agreements between the parties for execution.

The Supplier/Contractor/ Service Provider/Consultant should acknowledge and unconditionally accept, sign, date and return the agreement within 14 days from the date of issue of LOA/PO/Work Order. If both parties simultaneously sign the contract across the table, further acknowledgement from the supplier is not required.

Non- execution of Contract Agreement by the Supplier/Contractor/Service Provider within 30 days from the date of issue of LOA/PO/Work Order due to the fault of the Supplier/Contractor/Service Provider, will constitute sufficient ground for forfeiture of its EMD (wherever applicable) and shall short close the Contract. and retender and in this re-tender such defaulting Bidder will not be allowed to participate.

15. TERMINATION:

-

Termination shall be guided as per clause no. 24 under OPTIONAL TERMS & CONDITIONS OF CONTRACT of GCC.

16. SPLITTING OF CONTRACT:

DVC reserves the right to split the quantity equally among three Service providers (subject to price match with L1).

For this purpose, the evaluated L2 and L3 bidder shall be requested to match their total quoted amount with L1 total quoted amount along with all the terms and conditions of GeM Bid. After obtaining the favourable consent from evaluated L2 and L3 bidder, quantity to be executed shall be split up equally among the L1, L2 and L3 bidders. In the event of L2 or L3 bidder doesn't agree to match the L1 quoted amount, possibilities shall be explored with L4, L5 and so on as the case may be in seriatim in an attempt to finalise the tender. **In case no bidder agrees to match the L1 offer amount, placement of order to execute the total quantity shall be placed on L1 or retender for balance quantity is to be decided solely by DVC.**

NOTE: 1. Wherever there is any conflict, the provisions in Buyer Added Bid Specific Terms and Conditions and all other terms & conditions of Vol-I: Invitation for Bids (IFB), Vol-II: Instructions to Bidders (ITB) , Vol-IV : Scope of Work, Technical Specification and Other Terms & Conditions, Vol-V: Special Conditions of Contract (SCC), Vol-VI: Bid Forms & Procedures (BFP) shall prevail over those in the DVC's GCC.
