**QUALIFYING REQUIREMENTS:**

## A. TECHNICAL CREDENTIALS

1. The vehicles should be registered as Public Service / Commercial vehicle having registration not earlier than five (05) years from the date of issuance of this NIT and should possess all the valid documents as needed by statutory authorities like MV Act. Minimum Seating Capacity of the vehicle to be of 07 persons or of the model specified.

  - a. Bidder should be the owner of vehicle and Bidder will be required to submit the Owner Book of Vehicle along with document for Registration of vehicle etc. along with Bidder's offer.  
OR
  - b.
