# Commodity EXIM Report DGCI & S, I T J Division

- 1. The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns with respect to selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for making informed trade decision.
- 2. For both categories of trades, one commodity group is chosen from the entire ITC-HS 4-digit Classification (latest being 2024 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C&I Database, global export-import data of exactly those sets of commodities are sourced from UN-COMTRADE Database.
- 3. As regards the time-period, this report outlines trade statistics over a period of four years, i.e., 2021 to 2024. The latest finalized data available on the UN Comtrade Database is only up to year 2024 (Calendar Year) and on the DGCI&S Database up to September, 2025. So, for each commodity group dealt in this report, trends from 2021 to 2024 have been showcased where data has been sourced from UN Comtrade and from DGCI&S database.
- 4. In the instant report [4<sup>th</sup> weekly Commodity Exim Report of November, 2025 dated 26<sup>th</sup> November, 2025] the following two commodities have been dealt with.

Export: Motorcycles (Including Mopeds) and Cycles fitted with an Auxiliary Motor, with or without Side-Cars [ITCHS Code –8711] - In 2024 this commodity group had 0.71% share in India's total Export value basket as per DGCI&S database. India occupied the 4<sup>th</sup> slot in export of this commodity (exported 3112.44 million USD) with 7.67% share of total global exports in the year 2024.

Import: Soya-Bean Oil and its Fractions, whether or not refined, but not Chemically Modified. [ITCHS Code – 1507] – In 2024, this commodity group had share of 0.58% in India's total Import value basket as per DGCI&S database. India having 38.32% share of total global imports of this commodity (4131.22 million USD) occupied the top slot in the world in 2024.

#### **EXPORT**

Motorcycles (Including Mopeds) and Cycles fitted with an Auxiliary Motor, with or without Side-Cars classified as ITCHS Code – 8711 falls under Chapter – 87 (Vehicles other than railway or tramway rolling-stock, and parts and accessories thereof) of Section- XVII (Vehicles, Aircraft, Vessels and Associated Transport Equipment) ITC-HS classification.

India is engaged in the process of exporting this commodity and in 2024 this commodity group had 0.71% share in India's total Export value basket as per DGCI&S database.



India's top 10 destinations of Motorcycles and Cycles fitted with an Auxiliary Motor by Percentage in 2024




The total value of exports of Motorcycles (Including Mopeds) and Cycles fitted with an Auxiliary Motor, with or without Side from India amounted to USD 3161.17 million in 2024, rising by 20.80% from 2023 levels. Mexico (USD 394.30 million) held the top position as an export destination in this segment from India with 12.47% share of India's total export followed next by Colombia (USD 337.70 million) and Nigeria (USD 182.88 million) to where India exported around 10.68% and 5.79% share of Motorcycles (Including Mopeds) and Cycles fitted with an Auxiliary Motor, with or without Side respectively in 2024. For the period under review, exports of Motorcycles (Including Mopeds) and Cycles fitted with an Auxiliary Motor, with or without Side from India were at USD 2948.27 million in 2021 followed by almost flat trend in 2022 compared to the year 2021 and a dip in 2023 over 2022 levels and then increased in 2024 compared to 2023.



World's 10 leading exporters of Motorcycles and Cycles fitted with an Auxiliary Motor by percentage in 2024




The Motorcycles (Including Mopeds) and Cycles fitted with an Auxiliary Motor, with or without Side exports globally soared to USD 40596.90 million in 2024, decreased by 2.71% over the previous year. **India** occupied the 4<sup>th</sup> position (Exported USD 3112.44 million in this segment) with 7.67% share of world exports of Motorcycles (Including Mopeds) and Cycles fitted with an Auxiliary Motor, with or without Side Cars in 2024. The leading exporters in 2024 in this segment were China (USD 14543.35 million, Germany (USD 3353.17 million) and Japan (USD 3304.78 million) with 35.82%, 8.26% and 8.14% shares globally. India's share in this segment decreased till 2023 and then rose in 2024.




World's 10 leading importers of Motorcycles and Cycles fitted with an Auxiliary Motor (by percentage share in 2024)




The Motorcycles (Including Mopeds) and Cycles fitted with an Auxiliary Motor, with or without Side imports worldwide was USD 31984.84 million in 2024, decreased by 11% from 2023 levels. Over the period under review, global imports were at record high in 2022. **India** (importing goods worth a total of USD 70.44 million in this category with a show of 0.22%, stood at the 62<sup>nd</sup> slot in 2024 of world import of Motorcycles (Including Mopeds) and Cycles fitted with an Auxiliary Motor, with or without Side. The lead importers in this segment in 2024 were USA (12.49%), Germany (8.46%) and France (6.63%). World import in this segment increased in 2022 compared to the year 2021 and then decreased till 2024.

As per UN Comtrade database, the top 3 importers of Motorcycles (Including Mopeds) and Cycles fitted with an Auxiliary Motor, with or without Side-Cars globally were **USA**, **Germany and France**. Out of these three countries, USA, Germany and France have imported 2.12%, 2.15% and 1.79% share of Motorcycles (Including Mopeds) and Cycles fitted with an Auxiliary Motor, with or without Side-Cars from India in 2024 which are presented below:



### **IMPORT**

**Soya-Bean Oil and its Fractions, whether or not refined, but not Chemically Modified** classified as ITCHS Code – 1507 falls under Chapter -15 (Animal, vegetable or microbial fats and oils and their cleavage products; prepared edible fats; animal or vegetable waxes) of Section – III (Animal, Vegetable or Microbial Fats and Oils and their Cleavage Products; prepared edible fats; Animal or Vegetable Waxes) of ITCHS classification.

India is engaged in the process of importing this commodity and in 2024 this commodity group had share of 0.58% share in India's total Import value basket as per DGCIS database.

India is a major importer of Soya-Bean Oil and its Fractions, whether or not refined, but not Chemically Modified. In 2024, India's crude Soya-Bean Oil and its Fractions, whether or not refined, but not Chemically modified imports were valued at nearly USD 4189.92 million, with Argentina, Brazil and Netherland were the top suppliers. In 2024 India's import in this segment increased by more than 3.03% compared to the year 2023. As per available data, Argentina was India's top importing partner in this segment with a share of 55.99%, followed by Brazil and Netherland with shares of 17.65% and 7.03% respectively. India's import value in this segment had a huge jump in 2022 over 2021 levels and then a major dip in 2023 compared to 2022, again it increased in 2024 from 2023 levels.

Global Soya-Bean Oil and its Fractions, whether or not refined, but not Chemically Modified imports totaled USD 10780.03 million in 2024 which was 11.45% lower than the previous year's value. India, the dominant global importer, representing the largest share of value in 2024, importing 38.32% share of global import value in this segment followed next by Canada (7.61%) and Peru (5.39%). Over the period under review India's import share in this segment increased in 2022 compared to 2021 and then decreased in 2023 over 2022 and again increased in 2024 over 2023.
