- (a) To provide Pre-Feasibility Report (PFR), Detailed Project Report (DPR) along with comprehensive cost estimate and cost benefit analysis for setting up the coal to chemical (downstream product) plant based on Surface Coal Gasification at identified site adjacent to Mahamaya OCP, Bhatgaon area, SECL.
 - (b) Finalizing capacity of the gasification plant along with chemical (downstream product) based on existing and future demand-supply scenario, market survey, feasibility, saleability, scalability, marketability, profitability, Design, Build, Operate, Maintain Production Plant(s), sell the downstream Product with revenue sharing to SECL from the proposed plant .
 - (c) Assessment of techno-commercial and economic viability of the final product/chemical (downstream product) from coal, based on existing and future demand-supply scenario, market survey; saleability, feasibility, marketability etc.
 - (d) To set up the coal to chemical (downstream product) plant based on Surface Coal Gasification in Joint Venture (JV) Business model with SECL as the lead partner with equity participation or in the Employer-Agency concept i.e. through Lumpsum Turnkey (LSTK)/Build, Own, Operate (BOO)/Build, Own, Operate ,Transfer(BOOT)/Engineering, Procurement, Construction (EPC) mode etc.
 - (e) To provide information about the uses of the final product/chemical (downstream product) to produce and potential customer market of the intended chemical (downstream product).
 - (f) To provide anticipated Margin per MT of chemical (downstream product) from proposed plant after successful commissioning of plant.


