## Commodity EXIM Report DGCI & S, I T J Division

The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns w.r.t. selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for better policy making.

- 2. For both categories of trades, one commodity group is chosen from the entire ITC-HS 4 digit Classification (latest being 2022 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C&I Database, global export-import data of exactly those sets of commodities are sourced from UN-COMTRDADE Database.
- 3. As regards the time-period, this report outlines trade statistics over a period of four years. Currently (for reports being prepared in CY 2024) we are considering the time-period of 2020-2023(Calendar year data). The latest finalized data available on the UN Comtrade Database is only up to year 2022 and on the DGCI&S Database up to December,2023. So, for each commodity group dealt in this report, trends from 2019 to 2022 have been showcased where data has been sourced from UN Comtrade and from 2020 to 2023 when sourced from DGCI&S database; however, for computation of commodity group's share in India's overall export basket and import basket we have had to use FY (financial year) data as all aggregate level data in India are represented in FY format.
- 4. In the instant report [4<sup>th</sup> weekly Commodity Exim Report of February,2024 dated 28<sup>th</sup> February, 2024] the following two commodities have been dealt with.

Export: Medicaments (Excluding Gods of Heading 3002, 3005 or 3006) Consisting of mixed or unmixed products for Therapeutic or Prophylactic uses (ITCHS Code – 3004) - In FY 2023-2024 (April –December'23) this commodity group has a significant 4.51% share in India's total Export value basket as per DGCI&S data base. India had occupied the 9<sup>th</sup> slot in export of this commodity with (17450.22 million USD) 3.99% share of total global exports in the year 2022.

Import: Palm Oil and its Fractions, whether or not refined, but not chemically modified classified [ITCHS Code – 1511] - In FY 2023-2024(April - December'23) this commodity group had share of 1.30% in India's total Import value basket as per DGCI&S data base. India having 22.63% share of total global imports of this commodity occupied the top slot in the 2022 and India's imports in this segment has consistently increased from US\$ 5408.89 million in 2019 to US\$ 11728.74 million in 2022.

## **EXPORT**

Medicaments (Excluding Gods of Heading 3002, 3005 or 3006) Consisting of mixed or unmixed products for Therapeutic or Prophylactic uses classified as H.S. Code – 3004 falls under Chapter - 30 (Pharmaceutical products) of Section VI (Products of the chemical and allied industries) of ITC-HS classification. Chapter 30 contributes significantly to India's export earnings especially in recent few years.

India is engaged in the process of exporting this commodity and in 2023-2024 FY this commodity group has so far (April-December, 2023) had 4.51% share in India's total Export value basket as per DGCI&S data base.



India's top 5 destinations of Medicaments by percentage share in 2023




In the year 2023 (Calendar Year) India had exported Medicaments (Excluding Gods of Heading 3002, 3005 or 3006) worth of US\$ 18822.62 million and registered an increase of 7.90% compared to 2022 figures of US\$ 17443.98 million. USA (importing US\$ 7225.76 million worth of goods in this segment from India) has held the top slot as an export destination in this segment with a significant 38.39% share of India's total exports in this segment recorded for the year 2023. In second and third place were UK (US\$ 599.80 million) and South Africa (US\$ 592.50 million) to where India exported around 3.19% and 3.15% of the commodity respectively in 2023; however, their shares are extremely limited.



World's 5 leading exporters of Medicaments (percentage share in 2022):




The Medicaments (Excluding Gods of Heading 3002, 3005 or 3006) exports worldwide was US\$ 437055.55 million in 2022, with an increase by 6.25% compared to 2021 level. Over the period under review, global exports, were at record high at US \$ 437055.55 million in 2022. **India** (exporting goods worth a total of US\$ 17450.22 million in this category) with a show of 3.99% share, stood at 9<sup>th</sup> position globally. The lead exporter in this segment was Germany (US\$ 74786.22 million) with 17.11% share of world exports followed by Switzerland (US\$ 46442.43 million) with 10.63% and USA(US\$ 34618.61 million) with 7.92% share in 2022 respectively. India's performance has significantly improved over the years, however, in percentage share terms, India's share has remained limited around 4% mark with 4.21% being the highest in global pandemic hit year of 2020.



World's 5 leading importers of Medicaments (percentage share in 2022)




The Medicaments imports worldwide was US\$ 456589.47 million in 2022, increasing by 3.31 % from 2021 levels. The lead importers in this segment in 2022 have been USA (20.14%), Germany (7.51%), and Switzerland (6.94%). **India** with a show of only 0.25% share in this category, stood at 53<sup>rd</sup> position globally. Global import value in this segment has steadily increased from 2019 till 2022. The top 3 importers of this product are USA, Germany and Switzerland, on the other hand these 3 nations are also the top 3 exporters of this products in the world with variations in their ranking. Further, eight-digit item wise analysis of this segment may provide us with some insight full imports and facts.


A difference is observed between global exports and global imports of this segment as recorded in UN Comtrade database. In 2022 global imports exceeded global exports by US\$ 19533.92 million.

As per UN Comtrade data base the top 3 importers of Medicaments (Excluding Gods of Heading 3002, 3005 or 3006) globally were **USA**, **Germany and Switzerland**. These 3 countries had imported 9.46%, 1.72% and 0.09% share of their total import of this commodity from India in 2022 which are presented below:

## **IMPORT**

Palm Oil and its Fractions, whether or not refined, but not chemically modified classified as ITCHS Code – **1511** falls under Chapter -15 (Animal, vegetable or microbial fats and oils and their cleavage products; prepared edible fats; animal or vegetable waxes) of Section – III (Animal or Vegetable fats and oils and their cleavage products; animal or vegetable waxes etc) as per ITC–HS Classification.

India is engaged in the process of importing this commodity and in 2023-2024 (April-December'23) this commodity group had share of 1.30% in India's total import value basket as per DGCI&S data base. Palm Oil and its fractions is one of India's traditional imported items.

The total amount of India's import in this segment in 2023 (Calendar Year) stood as US\$ 8786.79 million registering a huge decrease by 24.83 over 2022 figures of US\$ 11688.61 million. Indonesia has persistently been India's lead import- country partner in this segment as observed from 2020 to 2023. 52.38% share of India's total imports of Palm Oil and its Fractions was sourced from Indonesia in 2023, followed next by Malaysia and Thailand with shares of 27.54% and 8.92% respectively. India's import value in this segment has been steadily increasing from US\$ 5111.09 million in 2020 to US\$ 11688.61 million in 2022 followed by a major observable decline now in 2023.

It is observed that all the leading source country partners are Asian nations with the top 3 nation binning from South – East Asian Region.

Worldwide import of Palm Oil and its Fractions totalled to US\$ 51830.84 million in 2022 recording a 8.29% rise over 2021 levels. **India** imported US\$ 11728.74 million worth of the commodity in 2022, making it the leading importer of the commodity group worldwide with 22.63% share of world imports. China (11.27%) and Pakistan (7.34%) lined up in second and third place in 2022 with wide difference compared to India. Over the period under review the global imports in this segment has steadily been rising from 2019 till 2022 with a major leap in 2021 from 2020 levels just after the pandemic effect. India's share in the global landscape has also increased from 18.93% in 2019 to 22.63% in 2022 with a plunge in 2020 when share was 16.20%.
