- 4.1 The intending bidders are advised to visit the site of work before submitting their e-tenders.
- 4.2"The estimates are prepared based on rates of Common SR 2023-24 and GST 18% added to the estimated amounts as mentioned in SR. The estimated amount put to tender for the work is exclusive of "GST".
- 4.3. However the comparison will be done with Re-casted estimated based on rates of Common SR 2023-24 with prevailing Cement & Steel items of that Quarter (If any). The contractor should bid based on the Re-casted estimate amount (excluding GST but including all other charges as applicable). 18% GST shall be paid to the tendered amount separately. Further the increase in GST shall not be paid in the extended period of contract for which the contractor alone is responsible for delay as determined by the Authority while granting extension of time as per provisions.

- 4.10 1 % LabourCess as per provision of building and the construction works welfare act 1996 will recover from each running bill of the contractor.
- 4.11 If the rate(s) quoted by the contractor for any item(s) of work are below 90% of the estimated rates of the department then the contractor shall furnish an additional performance security in the form of Bank Guarantee for an amount equivalent to the difference between the cost as per quoted rate and 90% of the amount put to tender at the time of Executing the agreement.
