### Commodity EXIM Report DGCI & S, I T J Division

The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns w.r.t. selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for better policy making.

2. For both categories of trades, one commodity group is chosen from the entire ITC-HS 4-digit Classification (latest being 2023-2024 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C & I Database, global export-import data of exactly those sets of commodities are sourced from UN-COMTRDADE Database.

3. As regards the time-period, this report outlines trade statistics over a period of four years. Currently (for reports being prepared in FY 2023- 2024) we are considering the time-period of 2020-2021 to 2023-2024(Financial year data). The latest finalized data available on the UN Comtrade Database is only up to year 2023 (Calendar Year) and on the DGCI&S Database up to August 2024. So, for each commodity group dealt in this report, trends from 2020 to 2023 have been showcased where data has been sourced from UN Comtrade and from 2020-2021 to 2023-2024 when sourced from DGCI&S database; however, for computation of commodity group's share in India's overall export basket and import basket we have had to use FY (financial year) data as all aggregate level data in India are represented in FY format.

4. In the instant report [4th weekly Commodity Exim Report of October,2024 dated 23<sup>rd</sup> October , 2024] the following two commodities have been dealt with.

**Export:** Mens or Boys Shirts (ITCHS Code – 6205) - In FY 2023-2024 this commodity group has 0.24% share in India's total Export value basket as per DGCI&S data base. India had occupied the  $2^{nd}$  slot in export of this commodity with (1045.29 million USD) with 10.62% share of total global exports in the year 2023.

**Import : Polymers of Vinylchloride or of other Halogenated Olefin [ITCHS Code – 3904]** – In FY 2023-24 this commodity group had share of 0.45% in India's total Import value basket as per DGCI&S data base. India having 16.42% share of total global imports of this commodity occupied the top slot in the 2023.

### **EXPORT**

Mens or Boys Shirts classified as ITCHS Code -6205 falls under Chapter -62 (Articles of apparel and clothing accessories, not knitted or crocheted) of Section- XI (Textiles and Textile Articles) of ITC-HS classification.

India is engaged in the process of exporting this commodity and in 2023-2024 FY this commodity group has so far (April,23-March,2024) had 0.24% share in India's total Export value basket as per DGCI&S data base.

India's top 10 destinations of Mens or Boys Shirts by Percentage in 2023-2024



The total value of exports of Mens or Boys Shirts from India amounted to US\$ 1056.88 million in 2023-2024 with a little decrease of over 2.46% compared to 2022-2023 figures of US\$ 1083.50 million. For, the period under review, India's exports in this segment has steadily been rising from 2020-2021 till 2022-2023 with a major leap in 2022-2023 and little dip in 2023-2024. USA (US \$ 392.07 million) has held the top slot as an export destination in this segment from India with 37.10% share of India's total exports of this product group in 2023-2024. In second and third place were UAE (US\$ 83.46 million) and Netherland (US\$ 65.94 million) to where India exported around 7.90% and 6.24% share of Mens or Boys Shirts in 2023-2024. Several European countries figure in the above list/table as leading export destinations in this segment.

The Mens or Boys Shirts exports world wide amounted to US\$ 9844.25 million in 2023 an decreasing by 8.85% over the previous year. The lead Exporter in this segment has consistently been China exporting goods worth a total of US \$ 2216.23 million) with a show of 22.51% share in 2023. **India** (exporting goods worth a total of US\$ 1045.29 million) with a show of 10.62% share, stood at 2<sup>nd</sup> slot in 2023 of world export of Mens or Boys followed by Italy (US\$ 731.11 million) with 7.43% shares of world exports in this segment in 2023. India's share has gradually been increasing till 2022 & slight dip in 2023.

The Mens or Boys Shirts imports worldwide was US\$ 12136.71 million in 2023, a little decreased from 2022 levels. Over the period under review global imports were at record high in 2022. The lead importer in this segment with highest share of imports has primarily been USA (24.87% share in 2023) followed next by Germany (7.97%) and Japan (5.49%). **India** has 1% share world importing trade in this segment and occupied the 20<sup>th</sup> slot in 2023. Over the period under review Germany was the 4<sup>th</sup> largest exporter in global export of Mens or Boys Shirts in 2023, on other hand this country was also the 2nd largest importer of the commodity.

A difference is observed between global exports imports of this segment as per UN Comtrade. In 2023 global imports exceeded global exports by US\$ 2292.46 million.

As per UN Comtrade database the to 3 importers of Heterocyclic Compounds with Nitrogen were **USA**, **Germany and Japan**. These three countries had imported 11.28%, 9.67% and 2.34% share of their total import of this commodity from India in 2023 which are presented below :

**Polymers of Vinyl chloride or of other Halogenated Olefin** as ITCHS Code – 3904 falls under Chapter -39 (Plastics and articles thereof) of Section – VII (Plastics and Articles thereof; Rubber and Articles thereof) of ITCHS classification.

India is engaged in the process of exporting this commodity and in FY 2023 -24 this commodity group had share of 0.45% share in India's total Import value basket as per DGCIS data base.

The total amount of India's imports of Polymers of Vinyl chloride or of other Halogenated Olefin in 2023-2024 stood at US\$ 3063.17 million registering a decreased of approximately 13.79% over 2022-2023 levels. Over the period under review, India's imports in this segment were at record high at US \$ 3552.80 million in 2022-2023. In 2023-2024, China stood out as India's top importing partner in this segment with a share of 29.86% followed next by Japan (17.69%) and Taiwan (11.41%).

Total global imports of Polymers of Vinyl chloride or of other Halogenated Olefin worldwide was US\$ 20431.09 million in 2023 registering an little increasing by 28.82% from 2022 levels. Over the period under review, global imports were at record high at US \$ 28703.85 million in 2022 and from 2020 to 2023 the there is an observable increasing trend till 2022 and a major dip in 2023. **India's** imports amounted to approximately US \$ 3354.92 million in the year 2023 as per UN Comtrade database and **India** ranked 1<sup>st</sup> in the world with the share of 16.42% of total global imports of this commodity. The 2<sup>nd</sup> and 3<sup>rd</sup> largest importer in this segment has been Germany (US \$ 1428.92 million) and USA (US\$ 1397.76 million) with 6.99% and 6.84% share of global imports of this commodity respectively in 2023.
