# Commodity EXIM Report DGCI&S, ITJ Division

The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns with respect to selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for informed trade decision making.

2. For both categories of trades, one commodity group is chosen from the entire ITC-HS 4-digit Classification (latest being 2023-2024 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C & I Database, global export-import data of exactly those sets of commodities are sourced from UN-COMTRDADE Database.

3. As regards the time-period, this report outlines trade statistics over a period of four years, i.e., 2020-2021 to 2023-2024. The latest finalized data available on the UN Comtrade Database is only up to year 2023 (Calendar Year) and on the DGCI&S Database up to February,2025. So, for each commodity group dealt in this report, trends from 2020 to 2023 have been showcased where data has been sourced from UN Comtrade and from 2020-2021 to 2023-2024 when sourced from DGCI&S database.

4. In the instant report [4<sup>th</sup> weekly Commodity EXIM Report of April, 2025 dated 23<sup>rd</sup> April, 2025] the following two commodities have been dealt with:

- Export: Cruise ships, Excursion Boats Ferry Boats, Cargo Ships, Barges and Similar Vessels for the Transport of Persons or Goods [ ITCHS Code –8901 ] In FY 2023-2024 this commodity group has 0.34% share in India's total export value basket as per DGCI&S database. India had occupied the 12<sup>th</sup> slot in export of this commodity (exported 1124.06million USD) with 1.41% share of total global exports in the year 2023.
- Import: Coke and Semi-Coke of Coal, of Lignite or of Peat, Whether or not Agglomerated; Retort Carbon [ITCHS Code – 2704] –In FY 2023-24 this commodity group had share of 0.21% in India's total import value basket as per DGCI&S database. India having 12.50% share of total global imports of this commodity (1406.42 million USD) occupied the 2<sup>nd</sup>slot in the world in 2023.

#### **EXPORT**

**Cruise ships, Excursion Boats Ferry – Boats, Cargo Ships, Barges and Similar Vessels for the Transport of Persons or Goods** classified as H.S. Code – 8901 which falls under Chapter -89 (Ships, boats and floating structures) of Section-XVII (Vehicles, Aircraft, Vessels and Associated Transport Equipment ) as per ITC-HS classification.


India is engaged in the process of exporting this commodity and in 2023-2024 this commodity group had share of 0.34% share in India's total export value basket as per DGCI&S database.

The total value of export of Cruise ships, Excursion Boats Ferry – Boats, Cargo Ships etc from India in 2023-2024 amounted to USD 1502.88 million and registered a major increase of 51.23% compared to the


year 2022-2023 which figured to USD 993.75 million. For, the period under review, export of this segment was at USD 672.32 million in 2020-2021 followed by a decrease in 2021-2022 and then two major leaps in 2022-2023 and 2023-2024. UAE (USD 449.37 million) has held the top slot as an export destination in this segment with a whopping 29.90% share of India's total export followed by Maldives (USD 308.68 million) and Singapore (USD 288.03 million) to where India exported around 20.54% and 19.17% shares of total export of Cruise ships, Excursion Boats Ferry – Boats, Cargo Ships etc respectively in 2023-2024.



#### World's 10 leading exporters of Cruise ships, Excursion Boats Ferry – Boats, Cargo Ships etc percentage share in 2023




The global Cruise ships, Excursion Boats Ferry – Boats, Cargo Ships etc export reached at USD 79525.67 million in 2023, increasing by 13.59% over the previous year. The lead exporter in this segment has consistently been China (exporting goods worth a total of USD 25098.91 million) with a share of 31.56% of world export in 2023. Rep of Korea (USD 16715.38 million) and Japan (USD 9591.91 million.) with 21.02% and 12.06% shares of world export in this segment in 2023 stood at 2<sup>nd</sup> and 3<sup>rd</sup> slots respectively. **India** (exporting goods worth a total of USD 1124.06 million in this category) with a show of 1.41% share, stood at 12<sup>th</sup> slot in 2023 of world export of Cruise ships, Excursion Boats Ferry – Boats, Cargo Ships etc as per UN Comtrade Statistics. India's share has been increasing from 2021 till 2023.



# Leading importers of Cruise ships, Excursion Boats Ferry – Boats, Cargo Ships etc from 2020 to 2023




World's leading importers of Cruise ships, Excursion Boats Ferry – Boats, Cargo Ships etc by percentage share in 2023



The Cruise ships, Excursion Boats Ferry – Boats, Cargo Ships etc imports worldwide was USD 20243.22 million in 2023, increasing by 10.82% from 2022 levels. Over the period under review, global import was at record high at USD 27539.09 million in 2021 followed by a steep fall in 2022 and again an increase in 2023 with a major jump in 2021 compared to the 2020 figure. The lead importers in this segment in 2023 have been Germany (20.46%), Denmark (8.91%), and Rep. of Korea (7.33%) and **India** had 5.90% share in this segment and stood at 7<sup>th</sup> slot in the world.


• Note: As per UN Comtrade Statistics, there remains a huge mismatch between world export and world import of Cruise ships, Excursion Boats Ferry – Boats, Cargo Ships etc. In 2023 world export exceeded world import by USD 59282.45 million.

As per UN Comtrade database in 2023 the top 3 importers of Cruise ships, Excursion Boats Ferry – Boats, Cargo Ships etc globally were **Germany, Denmark and Rep. of Korea.** Germany and Rep. of Korea had not traded in this segment with India. Only Denmark had imported only 0.0000002% share of its total import of Cruise ships, Excursion Boats Ferry – Boats, Cargo Ships etc. from India in 2023. 

#### **IMPORT**

**Coke and Semi-Coke of Coal, of Lignite or of Peat, Whether or not Agglomerated; Retort Carbon** classified as ITC-HS Code 2704 falls under Chapter-27 (Mineral fuels, mineral oils and products of their distillation; bituminous substances; mineral waxes) and Section V (Mineral Products) of ITC-HS classification.

India is engaged in the process of importing this commodity and in 2023-2024 this commodity group had share of only 0.21% in India's total import value basket.

The total amount of India's import of Coke and Semi-Coke of Coal, of Lignite or of Peat, Whether or not Agglomerated; Retort Carbon in 2023-2024 stood at USD 1397.16 million registering a decline by approximately 17.64% from 2022-2023 which was USD 1696.47 million. In 2023-2024 Poland (USD 352.18 million) stood out as the top importing partner of India in this segment with a share of 25.21% followed by Indonesia (15.87%) and China (13.48%). For, the period under review, import of Coke and Semi-Coke of Coal, of Lignite or of Peat, Whether or not Agglomerated; Retort Carbon by India was at USD 605.47 million in 2020-2021 followed by an incremental trend and steep rise up to the year 2022-2023 and then a down turn in 2023-2024.

Import of Coke and Semi-Coke of Coal, of Lignite or of Peat, Whether or not Agglomerated; Retort Carbon worldwide was USD 11254.19 million in 2023 registering a reduction by more than 24% vis-à-vis the previous year's figure. In 202, **India** occupied the 2<sup>nd</sup> slot by way of importing up to 12.50% of global import of Coke and Semi-Coke of Coal, of Lignite or of Peat, Whether or not Agglomerated; Retort Carbon, followed by Germany with 10.13% share. The lead importer in this segment in 2023 was Brazil, who imported 16.67% share of global import of Coke and Semi-Coke of Coal, of Lignite or of Peat, Whether or not Agglomerated; Retort Carbon in 2023. India's import value in this segment has been steadily increasing over the years as observable from 2020 to 2022 in above table with a major leap in 2022 and a moderate dip in 2023.
