Commodity EXIM Report

The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns with respect to selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for informed trade decision making.

2. For both categories of trades, one commodity group is chosen from the entire ITC-HS 4-digit Classification (latest being 2024 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C & I Database, global export-import data of exactly those sets of commodities are sourced from UN-COMTRDADE Database.

3. As regards the time-period, this report outlines trade statistics over a period of four years, i.e., 2021 to 2024. The latest finalized data available on the UN Comtrade Database is only up to year 2024(Calendar Year) and on the DGCI&S Database up to May, 2025. So, for each commodity group dealt in this report, trends from 2021 to 2024 have been showcased where data has been sourced from UN Comtrade and from DGCI&S database.

4. In the instant report [5th weekly Commodity Exim Report of July ,2025 dated 30th June, 2025] the following two commodities have been dealt with.

Export : Articles of Jewellery and Parts thereof, of Precious Metal or of Metal Clad with Precious Metal [ITCHS Code –7113] -In year 2024 this commodity group has 2.78% share in India's total Export value basket as per DGCI&S data base. India had occupied the 4th slot in export of this commodity (12120.54 million USD) with 10.10% share of total global exports in the year 2024 and occupied the top slot in the world in 2024.

Import : Telephone Sets, Smartphone and other Telephones for cellular Networks; other Apparatus for Communication in a wired or Wireless Network [ITCHS – 8517] In year 2024 this commodity group had share of 2.46% in India's total Import value basket as per DGCI&S data base. India having 3.42% share of total global imports of this commodity (17387.73 million USD) occupied the 9th slot in the world in 2024.

EXPORT

Articles of Jewellery and Parts thereof, of Precious Metal or of Metal Clad with Precious Metal classified as H.S. Code – 7113 falls under Chapter -71(Natural or cultured pearls, precious or semi-precious stones, precious metals, metals clad with precious metal, and articles thereof; imitation jewellery; coin) of Section XIV (Natural or cultured pearls, precious or semi-precious stones, precious metals, metals clad with precious metal, and articles thereof; imitation jewellery; coin) of ITC-HS classification. Chapter 71 contributes significantly to India's export earnings especially in recent few years.

India is engaged in the process of exporting this commodity and in 2024 this commodity group has so far had 2.78% share in India's total Export value basket as per DGCI&S data base.

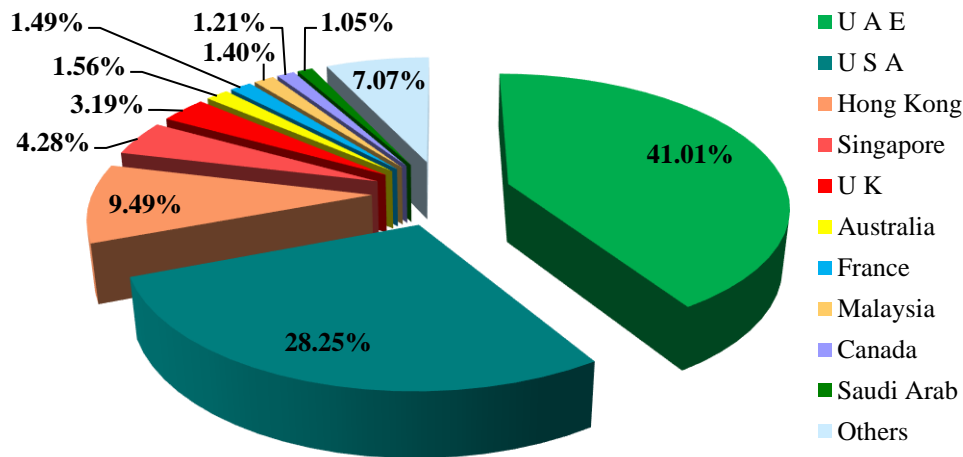

India's top 10 destinations of Articles of Jewellery and Parts thereof, of Precious Metal or Precious Metal clad by percentage share in 2024



India's Articles of Jewellery and Parts thereof, of Precious Metal or Precious Metal clad exports witnessed a little decline of 2.97% in the year 2024. The country exported US\$ 12324.08 million worth of the commodity in 2024, as compared to US\$ 12702 million in last year. India exports Articles of Jewellery and Parts thereof, of Precious Metal or Precious Metal clad to numerous countries. Key export partners include the UAE, USA and Hong Kong. UAE has a significant market for Articles of Jewellery and Parts thereof, of Precious Metal or Precious Metal clad exports from India, with exports valued at US\$ 5053.63 million in 2024 makes it UAE the top export destination for the commodity from India with 41.01% share of India's total export, followed by USA (US\$ 3481.96 million) and Hong Kong (US\$ 1169.09 million) with 28.25% and 9.49% share respectively.

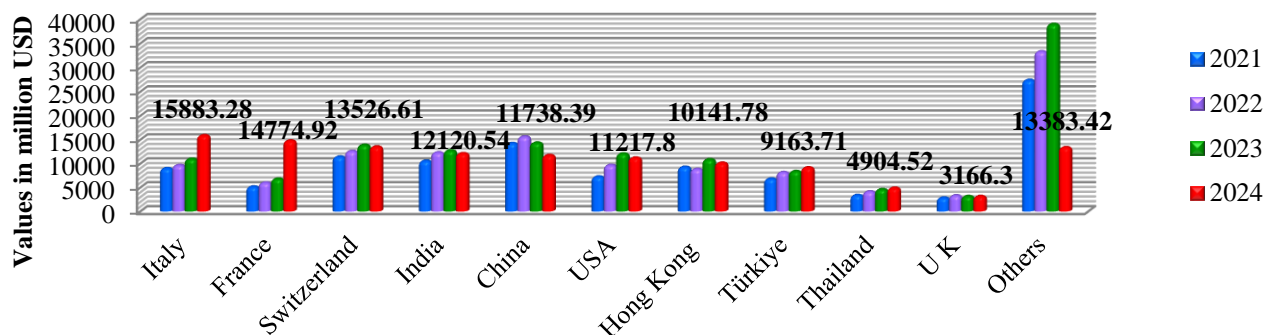
India's Articles of Jewellery and Parts thereof, of Precious Metal or Precious Metal clad export experienced a significant upward turn from 2021 to 2023 and experiencing a little dip in 2024.

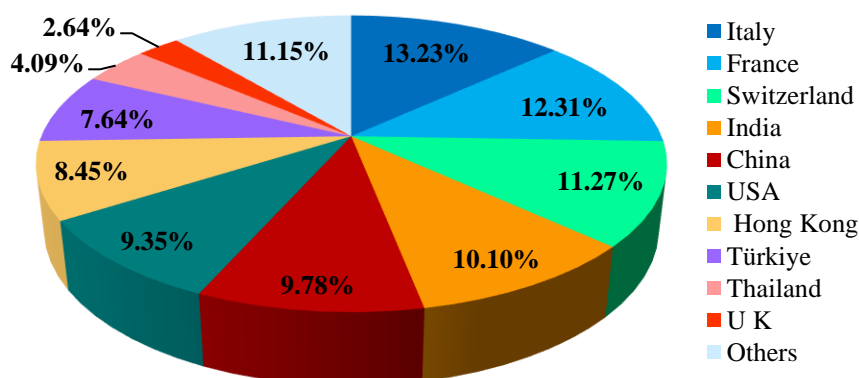

World's 10 leading exporters of Articles of Jewellery and Parts thereof, of Precious Metal or Precious Metal clad (percentage share in 2024)



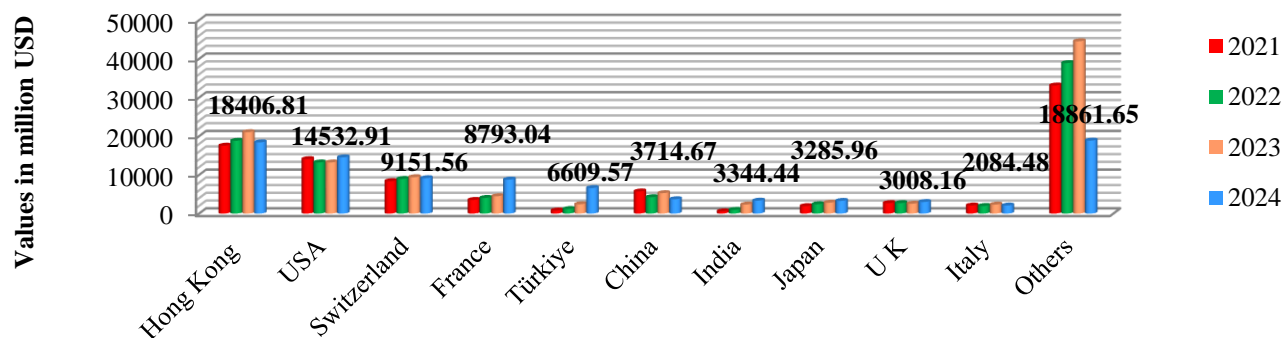
In 2024, worldwide exports of Articles of Jewellery and Parts thereof, of Precious Metal or Precious Metal clad reached an estimated US\$120021.26 million in total. However, in comparison to the previous year, 2023, global export of this commodity dipped by 12.23% from a higher \$136750.42 million. **India's** total Articles of Jewellery and Parts thereof, of Precious Metal or Precious Metal clad exports reached US\$12120.54 million in 2024, making it the world's 4th largest exporter of the commodity group in the world with 10.10% share globally. The leading exporting nations in this segment in 2024 were Italy (US\$ 15883.28 million), France (US\$ 14774.92 million) and Switzerland(US\$ 13526.61 million) with 13.23%, 12.31% and 11.27% share respectively. Global export in this segment, was at US\$ 107316.14 million in 2021, have been rose till 2023 experiencing a major leap in 2023 and major dip in 2024 compare to the year 2023.

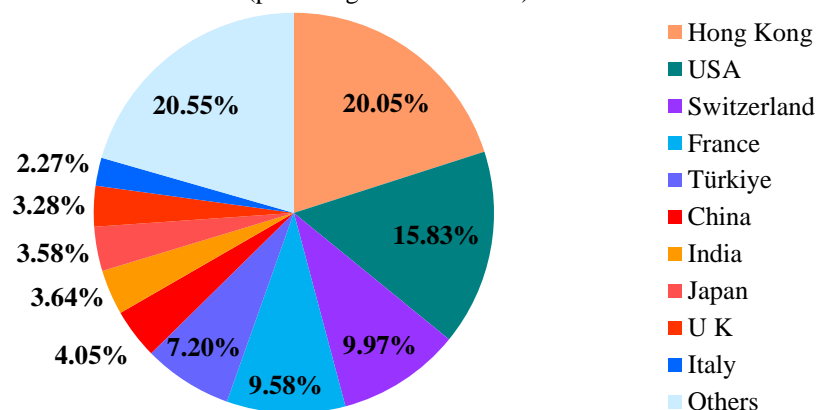

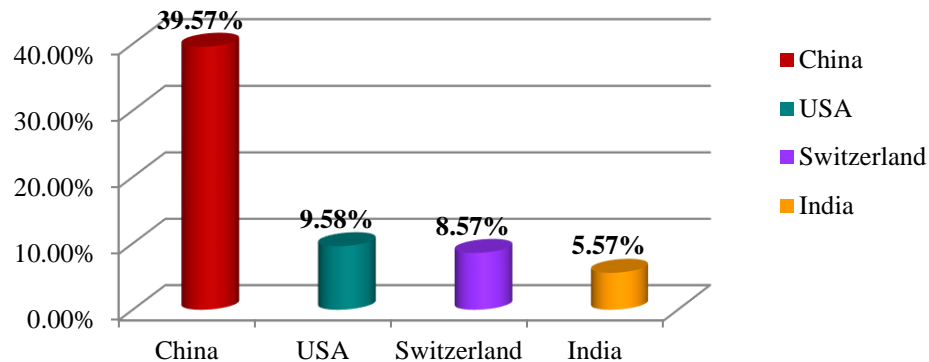
World's 10 leading importers of Articles of Jewellery and Parts thereof, of Precious Metal or Precious Metal clad (percentage share in 2024)



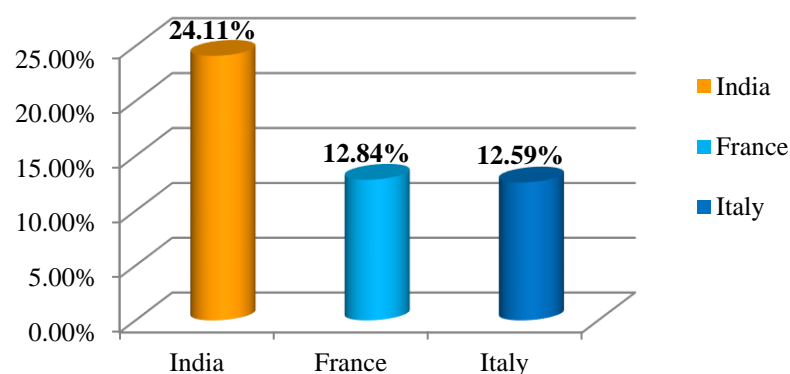
The Articles of Jewellery and Parts thereof, of Precious Metal or Precious Metal clad imports worldwide was US\$ 91793.25 million in 2024, decreasing by 16.89% from 2023 levels. Over the period under review, global imports of were at Articles of Jewellery and Parts thereof, of Precious Metal or Precious Metal clad record high in 2023. The lead importer in this segment had highest share of import has been Hong Kong (20.05%) in 2024 followed next by USA (15.83%) and Switzerland (9.97%). **India** has 3.64% share of world importing trade in this segment in 2024 and stood at 7th slot in the world . World import of Articles of Jewellery and Parts thereof, of Precious Metal or Precious Metal clad has steadily increased from till 2023 and then dip in 2024. A difference is observed between global exports and global imports in this segment as per UN Comtrade statistics. In 2024 global exports exceeded global imports by US\$ 28228.01 million.

As per UN Comtrade data base the top 3 importers of Articles of Jewellery and Parts thereof, of Precious Metal or Precious Metal clad globally were **Hong Kong, USA and Switzerland**. Out of these 3 country had imported 5.57%, 24.11% and 0.26% share of their total import of this commodity from India in 2024 which are presented below:

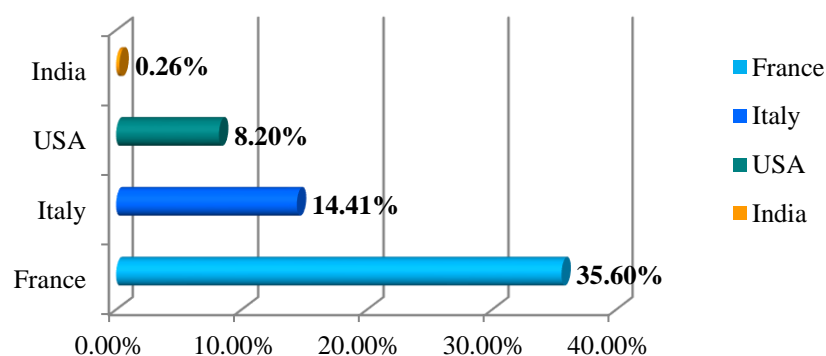

IMPORT

Telephone Sets, Smartphone and other Telephones for cellular Networks etc classified as H.S. Code – 8517 which falls under Chapter -85 (Electrical machinery and equipment and parts thereof; sound recorders and reproducers, television image and sound recorders and reproducers, and parts and accessories of such articles) of Section-XVI (Machinery & their Parts, Electrical & Electronic Equipment, Parts thereof) as per ITC-HS classification.

India is engaged in the process of importing this commodity and in 2024 this commodity group had share of 2.46% of India's total import value basket as per DGCI&S data base.

In 2024 India had imported a total of USD 17681.70 million worth of Telephone Sets, Smartphone and other Telephones for cellular Networks etc, a rise by 6.87% compare to the year 2023 when the trade value was US\$ 16544.88 million. As per available data, China stood out as India's top importing partner in this segment with a share of 43.43%. Next in line comes Ireland and Hong Kong with shares of 16.10% and 9.23% respectively. India's import of Telephone Sets, Smartphone and other Telephones for cellular Networks etc has been steadily increasing from US\$ 13224.96 million in 2021 to US\$ 17681.70 million in 2024 experiencing a major leap in 2022.

Worldwide import of Telephone Sets, Smartphone and other Telephones for cellular Networks etc totalled to US\$ 509107.58 million in 2024 recording a huge declined by nearly 17.87% over 2023 levels. USA imported US\$ 115085.71 million worth of the commodity in 2024, making it the leading importer of the commodity group worldwide with 22.61% share of world imports. Hong Kong (11.70%) and Japan (5.12%) lined up in second and third place in 2024. The import value of Telephone Sets, Smartphone and other Telephones for cellular Networks etc in **India** amounted to approximately US \$ 17387.73 million in the year 2024 and ranked 9th slot in the world with the share of 3.42% of total global import value of goods in this segment experiencing a continuous upwards trends till 2024.
