Commodity EXIM Report **DGCI & S, I T J Division**

1. The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns with respect to selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for informed trade decision making.
2. For both categories of trades, one commodity group is chosen from the entire ITC-HS 4-digit Classification (latest being 2024 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C&I Database, global export-import data of exactly those sets of commodities are sourced from UN-COMTRADE Database.
3. As regards the time-period, this report outlines trade statistics over a period of four years, i.e., 2021 to 2024. The latest finalized data available on the UN Comtrade Database is only up to year 2024(Calendar Year) and on the DGCI&S Database up to September, 2025. So, for each commodity group dealt in this report, trends from 2021 to 2024 have been showcased where data has been sourced from UN Comtrade and from DGCI&S database.
4. In the instant report [2nd weekly Commodity Exim Report of November, 2025 dated 12th November, 2025] the following two commodities have been dealt with.

Export : Meat of Bovine Animals, Frozen [ITCHS Code –0202] -In the year 2024 this commodity group had 0.80% share in India's total Export value basket as per DGCI&S database. India occupied the 4th slot in export of this commodity (exported 3502.47 million USD) with 10.03% share of total global exports in the year 2024.

Import : Platinum, Unwrought or in Semi-Manufactured form, or in Powder form [ITCHS Code–7110] –In the year 2024 this commodity group had share of 0.37% in India's total Import value basket as per DGCI&S database. India having 6.01% share of total global imports of this commodity (2648.60 million USD), occupied the 7th slot in the world in 2024.

EXPORT

Meat of Bovine Animals, Frozen classified as H.S. Code – 0202 falls under Chapter -02 (Meat and edible meat offal) of Section I (Live Animals; Animal Products) of ITCHS classification.

India is engaged in the process of exporting this commodity and in 2024 this commodity group had share of 0.80% in India’s total Export value basket as per DGCI&S database.

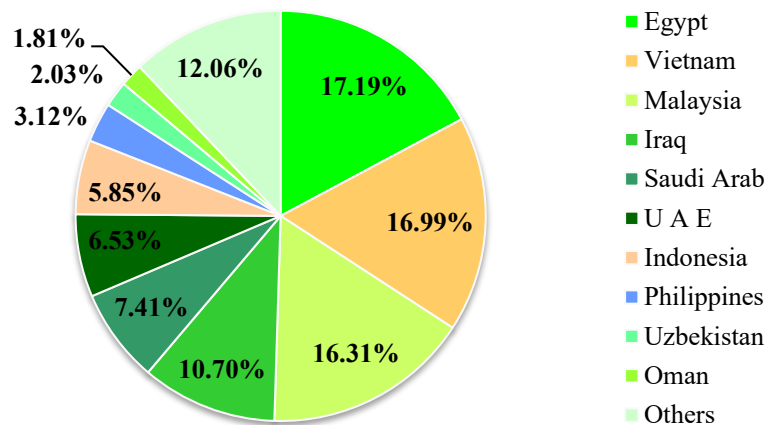

India’s top 10 destinations of Meat of Bovine Animals, Frozen Exports in 2024 (Percentage share)



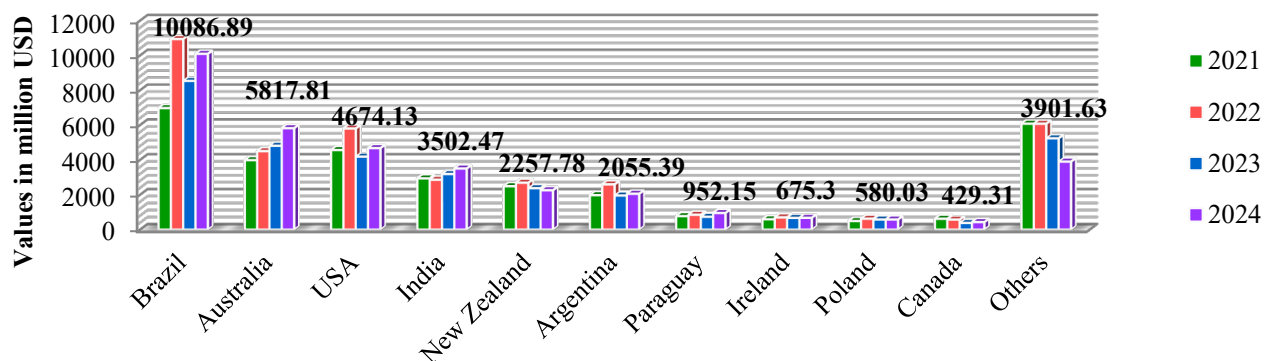
In the year 2024 India exported Meat of Bovine Animals, Frozen worth of USD 3555.52 million recorded an increase by 11.51% compared to 2023 figures of USD 3185.87 million. Egypt (importing USD 611.29 million worth of goods in this segment from India) held the top slot as an export destination with 17.19% share of India’s total exports, followed by Vietnam (USD 604.02 million) and Malaysia (USD 579.89 million) to where India exported around 16.99% and 16.31% of the commodity respectively in 2024. For, the period under review, exports of this commodity group were at USD 2936.85 million in 2021 followed by persistent down in 2022 just after the pandemic period, a moderate rise in 2023 followed by again an increase in 2024.

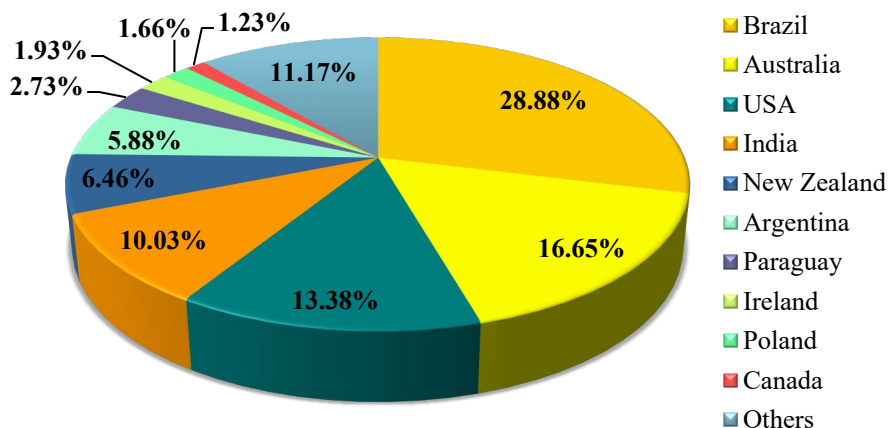

World's 10 leading exporters of Meat of Bovine Animals, Frozen in 2024 (Percentage share)



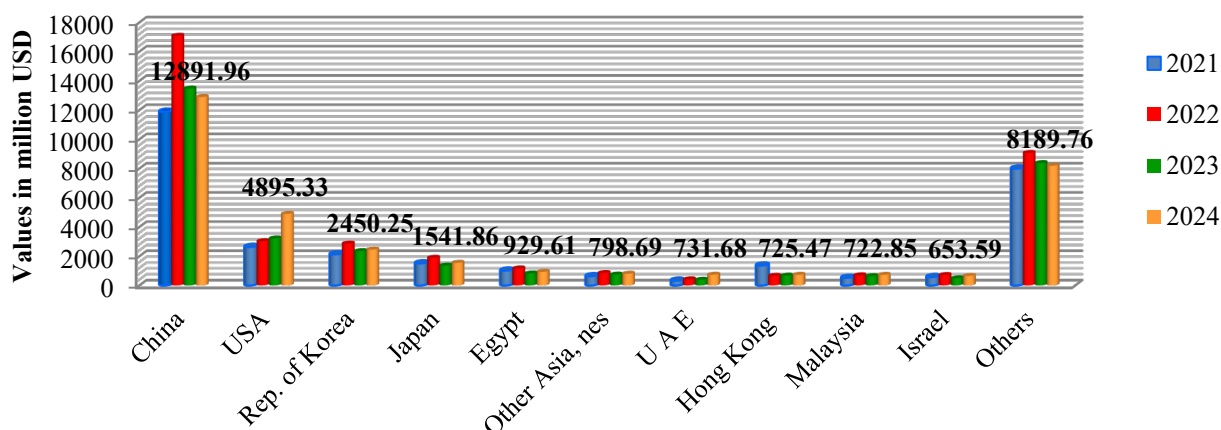
The global export of Meat of Bovine Animals, Frozen worldwide was USD 34932.88 million in 2024, increased by 7.06% from 2023 levels. Brazil (exporting goods worth a total of USD 10086.89 million in this category) with a show of 28.88% share, stood at top slot in 2024 of world export in this segment, followed by Australia (USD 5817.81 million) and USA (USD 4674.13) with 16.65% and 13.38% share. **India** (exporting goods worth a total of USD 3502.47 million in this category) with a show of 10.03% share, stood at 4th slot in 2024 of world export of Meat of Bovine Animals, Frozen. India’s export value in this segment were at USD 2936.54 million in 2021 and had little decrease in 2022 just after the pandemic year and then turned to positive trend till 2024.

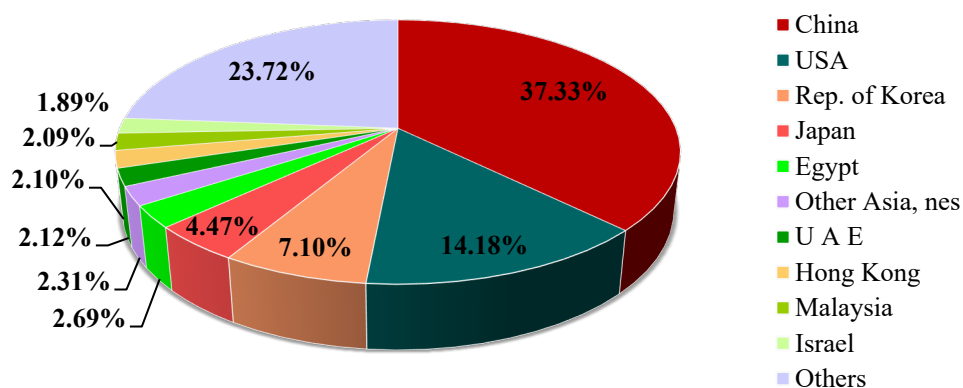

The Meat of Bovine Animals, Frozen imports worldwide was USD 34531.06 million in 2024, increased by 6.20% from 2023 level of USD 32513.56 million. The lead importers globally in this segment in 2024 was China (37.33%) followed by USA (14.18%), and Rep. of Korea (7.10 %). **India** had no import trade in this segment over the period under review. Over the period under review, global import value was at USD 30628.73 million in this segment in 2021 followed by a major increase in 2022 and then a major dip in 2023 and again an increase in 2024.

As per UN Comtrade database the top 3 importers of Meat of Bovine Animals, Frozen were **China, USA and Rep. of Korea**, but they had no trade with India in this segment in 2024.

IMPORT

Platinum, Unwrought or in Semi-Manufactured form, or in Powder form Classified as ITC Code 7110 falls under Chapter 71(Natural or cultured pearls, precious or semi-precious stones, precious metals, metals clad with precious metal, and articles thereof; imitation jewellery; coin) of Section XIV (Natural or cultured pearls, precious or semi-precious stones, precious metals, metals clad with precious metal, and articles thereof; imitation jewellery; coin) of ITC-HS classification.

India is engaged in the process of importing this commodity and in 2024 this commodity group had share of 0.37% in India's total import value basket.

The total amount of India's import of Platinum, Unwrought or in Semi-Manufactured form, or in Powder form in 2024 was USD 2682.02 million registering almost 9 times increase compared to the year 2023's figure of USD 297.77 million. In 2024 UAE was the top importing partner in this segment from where India imported 66.02% share of its total import of Platinum, Unwrought or in Semi-Manufactured form, or in Powder form, followed distantly by Thailand (19.44%) and Tanzania Rep. (6.67%). Over the period under review India's import value in this segment had a jump in 2022 over 2021 and again negative trend in 2023 compared to 2022 and again another jump in 2024 over 2023 level.

In 2024, the total global imports of Platinum, Unwrought or in Semi-Manufactured form, or in Powder form amounted to USD 44078.78 million, decreased by more than 11.53% vis-à-vis the previous year's figure. The lead Importer in this segment has consistently been USA (importing goods worth a total of USD 6976.38 million) with 15.83% share of world import in 2024 followed by China (USD 5568.83 million) with 12.63% and UK (USD 4535.30 million) with 10.29% share in 2024 respectively as per UN Comtrade Statistics. **India** (importing goods worth a total of USD 2648.60 million in this category) with 6.01% share, stood at 7th position in the world import in this segment in 2024.
