## Commodity EXIM Report DGCI & S, I T J Division

The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns w.r.t. selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for better policy making.

2. For both categories of trades, one commodity group is chosen from the entire ITC-HS 4-digit Classification (latest being 2023-2024 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C & I Database, global export-import data of exactly those sets of commodities are sourced from UN-COMTRDADE Database.

3. As regards the time-period, this report outlines trade statistics over a period of four years. Currently (for reports being prepared in FY 2023- 2024) we are considering the time-period of 2020-2021 to 2023-2024(Financial year data). The latest finalized data available on the UN Comtrade Database is only up to year 2023 (Calendar Year) and on the DGCI&S Database up to November, 2024. So, for each commodity group dealt in this report, trends from 2020 to 2023 have been showcased where data has been sourced from UN Comtrade and from 2020-2021 to 2023-2024 when sourced from DGCI&S database; however, for computation of commodity group's share in India's overall export basket and import basket we have had to use FY (financial year) data as all aggregate level data in India are represented in FY format.

4. In the instant report [4<sup>th</sup> weekly Commodity Exim Report of January,2025 dated 22<sup>nd</sup> January, 2025] the following two commodities have been dealt with.

**Export : Bars and Rods of Stainless Steel;Angles, Shapes and sections of Stainless steel [ITCHSCode 7222] -**In FY 2023-2024 (April,2023 –March,2024) this commodity group has 0.26% share in India's total Export value basket as per DGCI&S data base. India had occupied the 2<sup>nd</sup> slot in export of this commodity (1159.49 million USD) with 14.81% share of total global exports in the year 2023-2024.

**Import : Polycarboxylic Acids, Their Anhydrides, Haldides, Peroxides and Peroxyacids; Halogenated, Sulphonated, Nitrated Derivatives.** [ITCHS Code – 2917] –In FY 2023-24 (April 2023 – March,2024) this commodity group had share of 0.28% in India's total Import value basket as per DGCI&S data base. India having 12.08% share of total global imports of this commodity (1887.44 million USD) occupied the 2<sup>nd</sup> slot in the world in 2023.

### **EXPORT**

**Bars and Rods of Stainless Steel; Angles, Shapes and sections of Stainless steel.** classified as H.S. Code – 7222 falls under Chapter - 72 (Iron and steel) of Section XV (Base Metals and Articles of Base Metal) of ITC-HS classification.

India is engaged in the process of exporting this commodity and in 2023-2024 FY this commodity group has so far had 0.26% share in India's total Export value basket as per DGCI&S data base.

India's top 10 destinations of Bars and Rods; Angles, Shapes and sections of Stainless steel by percentage share in 2023-2024



In the year 2023-2024 India had exported Bars and Rods; Angles, Shapes and sections of Stainless Steel worth of US\$ 1128.08 million and registered an increase of 4.04% compared to 2022-2023 figures of US\$ 1084.33 million. Germany (importing US\$ 144.55 million worth of goods in this segment from India) has held the top slot as an export destination in this segment with 12.81% share of India's total export of Bars and Rods; Angles, Shapes and sections of Stainless Steel recorded for 2023-2024. In second and third place were Turkey (US\$ 104.42 million) and Italy (US\$ 101.44 million) to where India exported around 9.26% and 8.99% of total Bars and Rods; Angles, Shapes and sections of Stainless Steel respectively in 2023-2024. Over the period under review exports of Bars and Rods; Angles, Shapes and sections of Stainless Steel respectively in 2023-2024. Over the period under review exports of Bars and Rods; Angles, Shapes and sections of Stainless Steel from India were at US\$ 679.67 million in 2020-2021 followed by a rise in 2021-2022, a little dip in 2022-2023 followed by again an increase in 2023-2024.

The Bars and Rods; Angles, Shapes and sections of Stainless Steel exports worldwide was US \$ 7828.53 million in 2023 with a decrease by 8.66% compared to 2022 levels. Over the period under review global exports were at record high at US\$ 8571.08 million in 2022. **India** (exporting goods worth a total of U\$\$ 1159.49 million in this category) with a show of 14.81% share, stood at 2<sup>nd</sup> slot globally, followed next by Germany (US\$ 1045.65 million). The lead exporter in this segment has persistently been Italy (exporting goods worth a total of U\$\$ 1382.82 million) with 17.66% share of world export in 2023. India's share in global exports of this commodity had gradually been rising.

The Bars and Rods; Angles, Shapes and sections of Stainless Steel imports worldwide was US\$ 7573.59 million in 2023, decreasing by 9.88 % from 2022 levels. The lead importers in this segment in 2023 have been Germany (15.96%), USA (11.60%) and Italy (6.21%). **India** with a show of 1.33% share in this category, stood at 22<sup>nd</sup> position globally. Global imports in this segment had steadily increased from 2020 till 2022 and then dip in 2023.

As per UN Comtrade database the to 3 importers of Bars and Rods; Angles, Shapes and sections of Stainless Steel were **Germany, USA and Italy**. These three countries had imported 14.13%, 9.94% and 21.37% share of their total import of this commodity from India in 2023 which are presented below :

The total amount of India's import of Polycarboxylic Acids, Their Anhydrides, Haldides, Peroxides and Peroxyacids; Halogenated, Sulphonated, Nitrated Derivatives in 2023-2024 stood at US\$ 1905.71 million, recording a decrease of 12.19% compare to 2022-2023 figures of US\$ 2170.49 million. In 2023-2024 China stood out as the top importing partner in this segment from where India has imported 35.89% share of its total imports of this commodity followed next by Taiwan (19.94%) and Korea RP (16.72%) respectively in 2023-2024. India's import value in this segment has been steadily increasing from US\$ 786.59 million in 2020-2021 to US\$ 2170.49 in 2022-2023 and a dip in 2023-2024.

Worldwide import of Polycarboxylic Acids, Their Anhydrides, Haldides, Peroxides and Peroxyacids; Halogenated, Sulphonated, Nitrated Derivatives totalled to US\$ 15620.17 million in 2023 recording a massive declined by 24.07% over 2022 levels. Turkiye imported US\$ 1945.35 million worth of the commodity in 2023, making it the leading importer of the commodity group worldwide with 12.45% share of world imports. The import value of Polycarboxylic Acids, Their Anhydrides, Haldides, Peroxides and Peroxyacids; Halogenated, Sulphonated, Nitrated Derivatives in **India** amounted to approximately US\$ 1887.44 million in the year 2023 and **India** ranked 2<sup>nd</sup> in the world with the share of 12.08% of total global import value of goods in this segment followed next by USA (10.33%).
