Commodity EXIM Report

1. The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns with respect to selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for informed trade decision making.

2. For both categories of trades, one commodity group is chosen from the entire ITCHS 4-digit Classification (latest being 2024-2025 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C & I Database, global export-import data of exactly those sets of commodities are sourced from UN-COMTRADE Database.

3. As regards the time-period, this report outlines trade statistics over a period of four years, i.e, 2021-22 to 2024-25. The latest finalized data available on the UN Comtrade Database is only up to year 2024 (Calendar Year) and on the DGCI&S Database up to April, 2025. So, for each commodity group dealt in this report, trends from 2021 to 2024 have been showcased where data has been sourced from UN Comtrade and from 2021-22 to 2024-25 when sourced from DGCI&S database.

4. In the instant report [3rd weekly Commodity Exim Report of June, 2025 dated 18th June, 2025] the following two commodities have been dealt with.

Export : Bed Linen, Table Linen, Toilet Linen and Kitchen Linen [ITCHS Code –6302]

In FY 2024-25 this commodity group has 0.49% share in India's total Export value basket as per DGCI&S data base. India had occupied the 2nd slot in export of this commodity (2023.56 million USD) with 16.93% share of total global exports in the year 2024.

Import : Cyclic Hydrocarbons [ITCHS Code – 2902]

In FY 2024-25 this commodity group had a share of 0.46% in India's total Import value basket as per DGCI&S data base. India having 14.44% share of total global imports of this commodity (3194.56 million USD) occupied 2nd slot in the world in 2024.

EXPORT

Bed Linen, Table Linen, Toilet Linen and Kitchen Linen classified as H.S. Code – 6302 falls under Chapter -63 (Other made up textile articles; sets; worn clothing and worn textile articles; rags) of Section XI (Textiles and Textile Articles) of ITCHS classification.

India is engaged in the process of exporting this commodity and in FY 2024-25 this commodity group had 0.49% share in India’s total Export value basket as per DGCI&S data base.



India’s top 10 destinations of Bed Linen, Table Linen, Toilet Linen and Kitchen Linen by percentage share in 2024-25




India is a major exporter of Bed Linen, Table Linen, Toilet Linen and Kitchen Linen. In 2024-25, India's total exports of bed linen, table linen, toilet linen and Kitchen Linen amounted to USD 2128.63 million, experiencing a major increase of 14.51% compared to the previous year. For, the period under review, India's exports in this segment steadily decreased till 2023-24 and then increased in 2024-25. USA (USD 1329.77 million) has held the top slot as an export destination in this segment from India with 62.47% share of India's total export. Followed distantly by UK (USD 90.39 million) and Australia (USD 78.41 million), to where India exported around 4.25% and 3.68% share of Bed Linen, Table Linen, Toilet Linen and Kitchen Linen in 2024-25.



The Bed Linen, Table Linen, Toilet Linen and Kitchen Linen exports world wide amounted to USD 11950.16 million in 2024 with a major fall of 45.54% over the previous year. The lead Exporter in this segment has consistently been Pakistan (exporting the goods worth a total of USD 4305.39 million) with a show of 36.03% share in 2024. **India** (USD 2023.56 million) occupied the 2nd slot with 16.93% of global exports in this segment, followed next by Turkiye (USD 1082.09 million) with 9.06% share of world exports in this segment in 2024. Global export value in this segment had been facing a continuous fall from 2022 over the period under review with a major dip in 2024.





Top 10 importers of Bed Linen, Table Linen, Toilet Linen and Kitchen Linen from 2021 to 2024 (Data labels signified for 2024)




World's 10 leading importers of Bed Linen, Table Linen, Toilet Linen and Kitchen Linen Percentage share in 2024




The amount of the Bed Linen, Table Linen, Toilet Linen and Kitchen Linen imports worldwide was USD 17003.16 million in 2024, with a moderate decrease of 9.42% from 2023 levels. Over the period under review, global imports was at record high in 2021 and after that it had continuous decreasing trend till 2024. The lead importer in this segment with highest share of imports has primarily been USA (36.67% share in 2024) followed next by Germany (9.23%) and Japan (6.06%). **India** has only 0.15% share world importing trade in this segment and stood at 36th slot globally.

As per UN Comtrade database the top 3 importers of Bed Linen, Table Linen, Toilet Linen and Kitchen Linen were **USA, Germany and Japan**. These three countries had imported 35.53%, 7.49% and 3.57% share of their total import of this commodity from India in 2024 which are presented below:


(i) Top 3 supplier nations of Bed Linen, Table Linen, Toilet Linen and Kitchen Linen to USA in 2024 (percentage share)

IMPORT

Cyclic Hydrocarbons as ITCHS Code – 2902 falls under Chapter -29 [Organic chemicals] of Section – VI [Products of the Chemical or Allied Industries] of ITCHS Classification.

India is engaged in the process of importing this commodity and in the FY 2024-25 this commodity group had share of 0.46% in India’s total Import value basket as per DGCI&S data base.

The value of imports of Cyclic Hydrocarbons to India totalled USD 3347.14 million in 2024-25, which went up by 14.37% compared to 2023-24 figures of USD 2926.48 million. Over the period under review, India’s import value in this segment was USD 2334.39 million in 2021-22, steadily leap from 2023-24 to 2024-25. Singapore (USD 529.31 million) constitutes the largest source of Cyclic Hydrocarbons to India with 15.81% share of India’s total import of Cyclic Hydrocarbons in 2024-25, which was followed closely by Japan (USD 510.12 million) and Kuwait (USD 481.26 million) with 15.24% and 14.38% share respectively.

The worth value of Global import of Cyclic Hydrocarbons was nearly USD 22128.99 million in 2024 with a major fall by 47.81 % from the year 2023. USA was the world's largest importer of Cyclic Hydrocarbons with import value of USD 4215.22 million or 19.05% share of world’s import of Cyclic Hydrocarbons in 2024. **India** imported USD 3194.56 million worth of Cyclic Hydrocarbons making it the 2nd largest importer globally with 14.44% share worldwide followed by Belgium (USD 1914.97 million) with 8.65% share of total world import trade value of Cyclic Hydrocarbons in 2024. Global imports in this segment increased in 2022 compared to the year 2021 and then turned to decline till 2024 with a major dip in 2024.
