Commodity EXIM Report

DGCI & S, I T J Division

1. The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns with respect to selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for informed trade decision making.
2. For both categories of trades, one commodity group is chosen from the entire ITC-HS 4-digit Classification (latest being 2024 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C&I Database, global export-import data of exactly those sets of commodities are sourced from UN-COMTRADE Database.
3. As regards the time-period, this report outlines trade statistics over a period of four years, i.e., 2021 to 2024. The latest finalized data available on the UN Comtrade Database is only up to year 2024(Calendar Year) and on the DGCI&S Database up to November, 2025. So, for each commodity group dealt in this report, trends from 2021 to 2024 have been showcased where data has been sourced from UN Comtrade and from DGCI&S database.
4. In the instant report [2nd weekly Commodity Exim Report of January, 2026 dated 14th January, 2026] the following two commodities have been dealt with.

Export: SYNTHETIC ORGANIC COLOURING MATTER, WHETHER OR NOT CHEMICALLY DEFINED [ITCHS Code – 3204] - In 2024 this commodity group had 0.54% share in India's total Export value basket as per DGCI&S database. India occupied the 2nd slot in export of this commodity with (2340.67 million USD) 19.28% share of total global exports in the year 2024.

Import: ELECTRIC ACCUMULATORS, INCLUDING SEPARATORS THEREFOR, WHETHER OR NOT RECTANGULAR (INCLUDING SQUARE). [ITCHS Code – 8507] – In 2024 this commodity group had share of 0.20% in India's total Import value basket as per DGCI&S database. India (Imports of USD 3502.75 million) having 2.43% share of total global imports of this commodity, occupied 11th slot in 2024.

EXPORT

Synthetic Organic Colouring Matter, Whether or not Chemically defined classified as **ITCHS Code – 3204** which falls under Chapter -32 (Tanning or dyeing extracts; tannins and their derivatives; dyes, pigments and other colouring matter; paints and varnishes; putty and other mastics; inks) of Section VI (Products of the chemical or allied industries) of ITC-HS classification.

India is engaged in the process of exporting this commodity and in 2024 this commodity group had 0.54% share in India's total Export value basket as per DGCIS database.

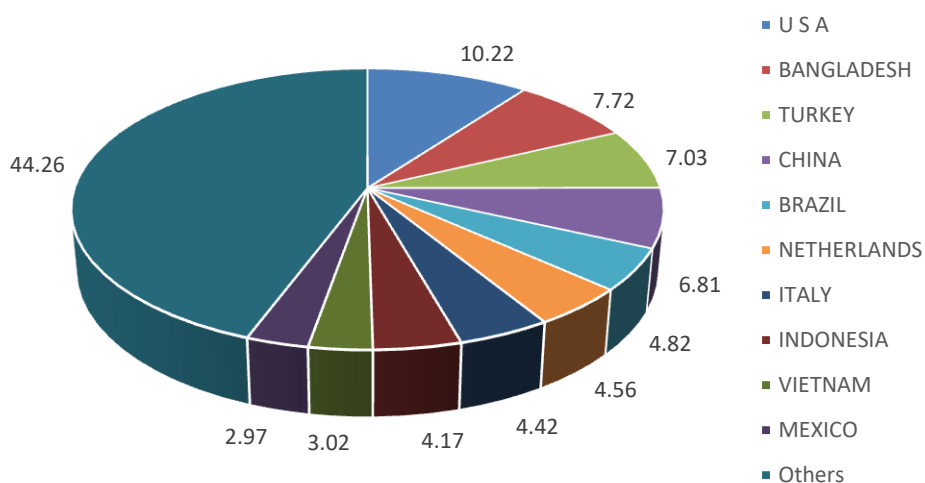

India's top 10 destinations of Synthetic Organic Colouring Matter, Whether or not Chemically defined by Percentage in 2024



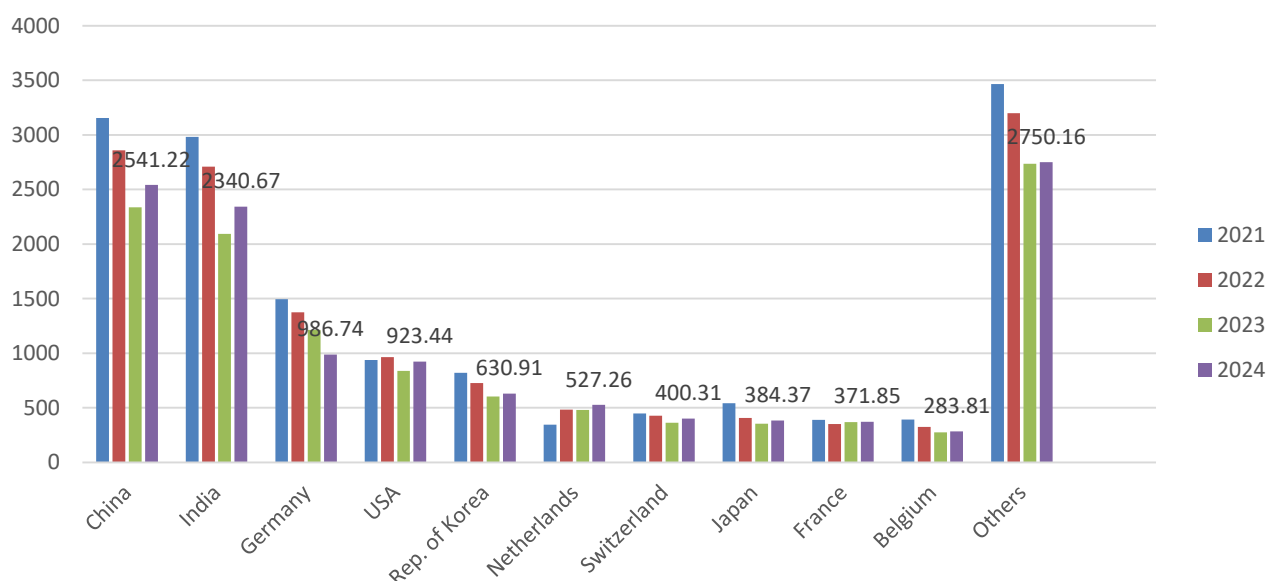
In the year 2024 India exported Synthetic Organic Colouring Matter, Whether or not Chemically defined worth of USD 2377.54 million, increased from 2023 figures of USD 2093.69 million. USA (importing USD 243.00 million worth of goods in this segment from India) held the top slot as an export destination in this segment with 10.22 % share of India's total exports of Synthetic Organic Colouring Matter, Whether or not Chemically defined in the year 2024. In second and third place were Bangladesh (USD 183.46 million) and Turkey (USD 167.06 million) to where India exported around 7.72% and 7.03% share respectively of total export of this commodity in 2024. Over the period under review India's exports in this segment decreased from 2021 to 2023 and then increased in 2024 over 2023 levels.

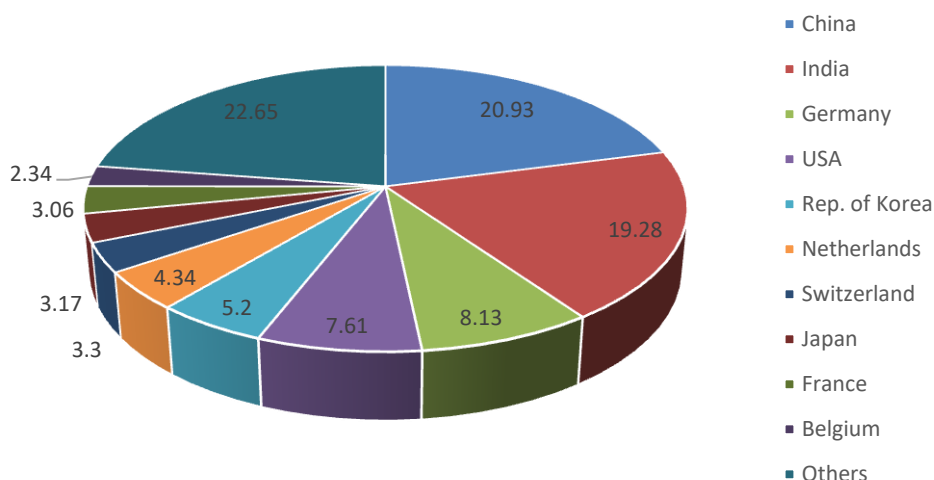

The worldwide exports of Synthetic Organic Colouring Matter, Whether or not Chemically defined amounted to USD 12140.74 million in 2024, increased from 2023 levels of USD 11656.58 millions. The lead Exporter in this segment has consistently been China (exporting goods worth a total of USD 2541.22 million) with 20.93% share in 2024. **India** (exporting goods worth a total of USD 2340.67 million in this category) with 19.28% share, stood at 2nd slot in 2024 of world exports of Synthetic Organic Colouring Matter, Whether or not Chemically defined followed by Germany (USD 986.74 million) with 8.13% share of world export in this segment in 2024. World export in this segment decreased from 2021 till 2023 and then increased in 2024 over 2023.

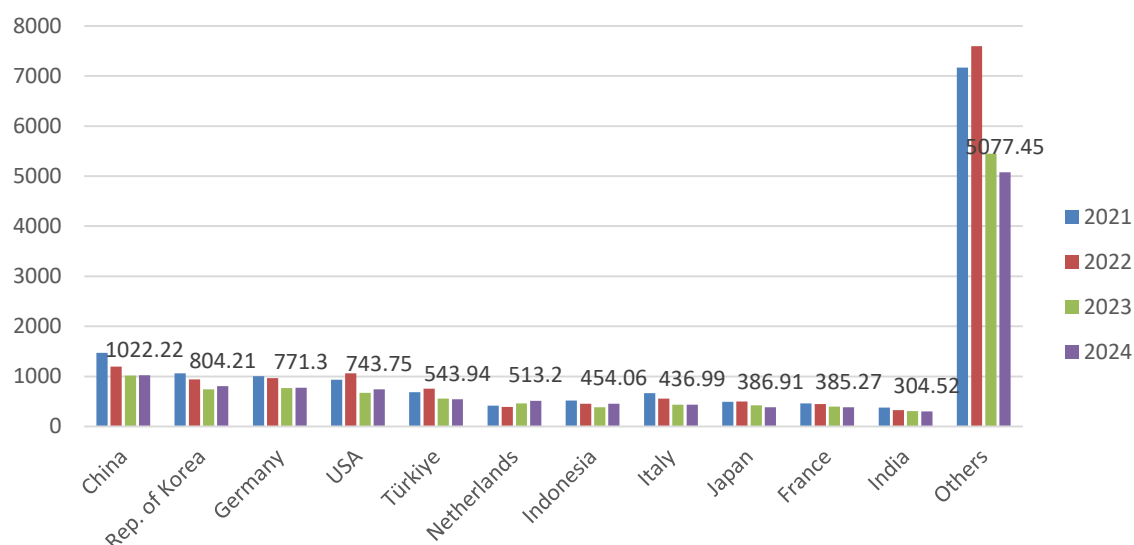

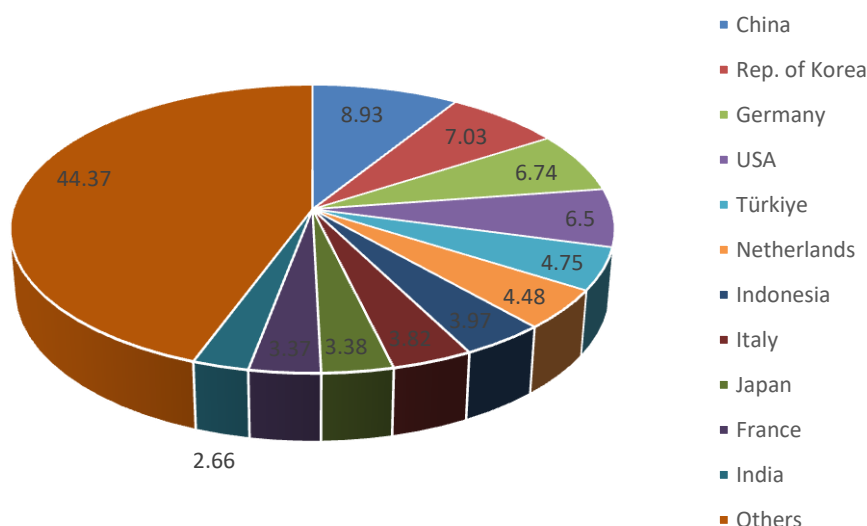

Leading Importers of Synthetic Organic Colouring Matter, Whether or not Chemically defined globally from 2021 to 2024 (Data labels signified for 2024)



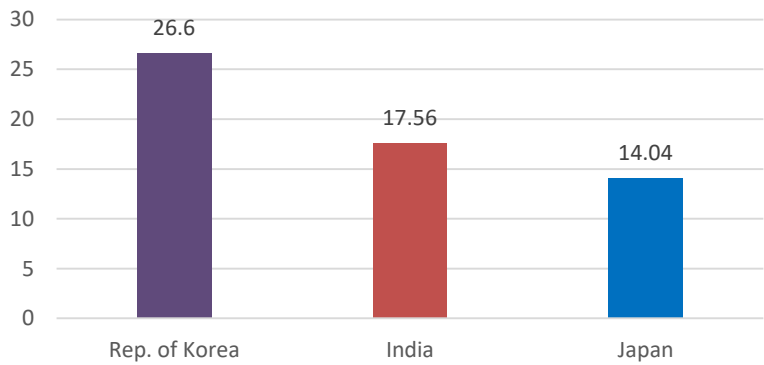
World's 10 leading importers of Synthetic Organic Colouring Matter, Whether or not Chemically defined (by percentage share in 2024)



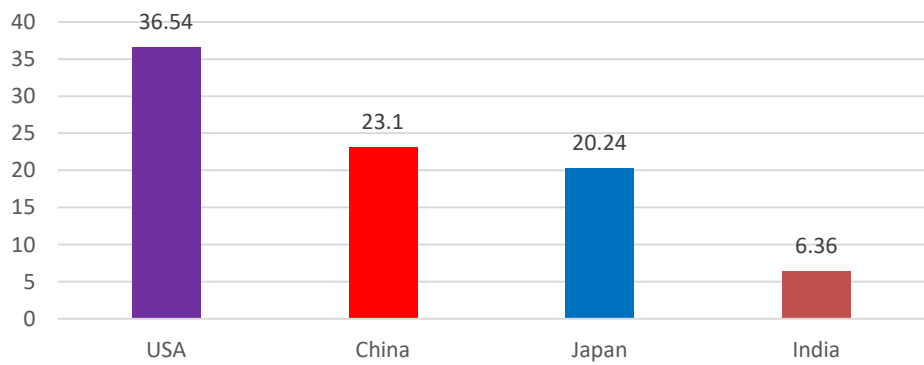
The worldwide imports of Synthetic Organic Colouring Matter, Whether or not Chemically defined was USD 11443.83 million in 2024, a little decreased from 2023 levels of USD 11622.37 million. Over the period under review (i.e. 2021-2024), global imports were at record high in 2021. The lead importer in this segment had highest share of import were China (8.93 %) in 2024 followed next by Rep. of Korea (7.03%) and Germany (6.74%). **India** had 2.66 % share of world importing trade in this segment in 2024 and stood at 13th slot in the world. World import of Synthetic Organic Colouring Matter, Whether or not Chemically defined followed a decreasing trend from 2021 to 2024.

As per UN Comtrade database the top 3 importers of Synthetic Organic Colouring Matter, Whether or not Chemically defined globally were **China, Rep. of Korea and Germany**. These 3 countries imported 17.56 %, 6.36 % and 16.84 % of their total import of Synthetic Organic Colouring Matter, Whether or not Chemically defined from India in 2024 which is presented below :

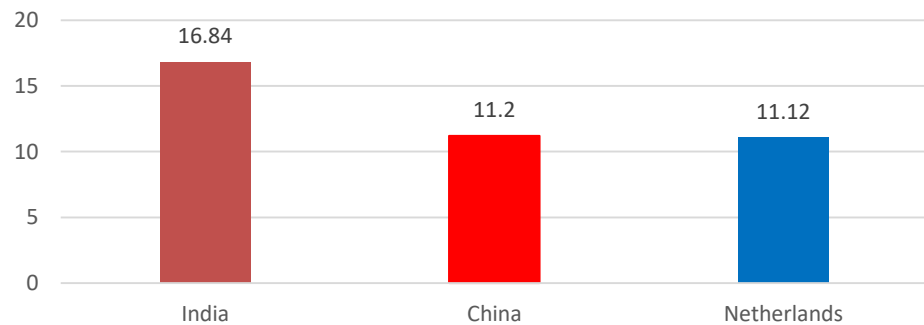
i) Top 3 supplier nations of Synthetic Organic Colouring Matter, Whether or not Chemically defined form to China in 2024 (Percentage share)

ELECTRIC ACCUMULATORS, INCLUDING SEPARATORS THEREFOR, WHETHER OR NOT RECTANGULAR (INCLUDING SQUARE) classified as ITCHS Code – 8507 which falls under Chapter - 85(Electrical machinery and equipment and parts thereof; sound recorders and reproducers, television image and sound recorders and reproducers, and parts and accessories of such articles) and Section XVI (Machinery and mechanical appliances; electrical equipment; parts thereof; sound recorders and reproducers, television image and sound recorders and reproducers, and parts and accessories of such articles) of ITC-HS classification.

India is engaged in the process of Importing this commodity and in 2024 this commodity group had share of 0.20 % share in India's total Import value basket as per DGCIS database.

The total amount of India's import of Electric accumulators, including separators therefor, whether or not rectangular (including square) in 2024 stood at USD 3564.68 million, decreased from 2023 levels of USD 3821.78 million. Over the period under review, India's imports in this segment were at record high at USD 3821.78 million in 2023. In 2024, China stood out as India's top importing partner in this segment with a share of 67.83% of India's total import in this segment followed next by Hong Kong (9.83%) and Rep. of Korea (7.73%). For, the period under review, India's imports in this segment increased till 2023 from 2021 levels and then decreased in 2024 over 2023 levels.

Worldwide Imports of Electric accumulators, including separators therefor, whether or not rectangular (including square) was USD 144229.56 million in 2024, decreased from 2023 levels of USD 157750.07 million. Over the period under review, global imports were at record high at USD 157750.07 million in 2023. **India's** imports of Electric accumulators, including separators therefor, whether or not rectangular (including square) amounted to approximately USD 3502.75 million in the year 2024. As per UN Comtrade database India ranked 11th slot in the world with the share of 2.43 % of total global imports of this commodity. The lead Importers in this segment were USA (USD 32435.65 million) with 22.49 % share, followed by Germany (USD 26030.12 million) and Mexico (USD 6626.08 million) with 18.05% and 4.59% share respectively of global imports of this commodity in 2024.
