1. INTRODUCTON

Kerala agro machinery corporation Limited (KAMCO)established in 1973, is a Public Sector Undertaking (under the Department of Agriculture Government of Kerala) having its Regd. Office at Athani – 683 585 in Ernakulam Dist., Kerala. It has six manufacturing units at ATHANI and KALAMASSERY in ERNAKULAM District, MALA in Thrissur District, KANJIKODE in Palakkad District and in Kannur district. KAMCO is a pioneer company in the manufacturing of various models of Power Tillers in India. Apart from Power Tillers, KAMCO is also producing various models of Power Reapers, Garden Tillers, Pump Sets and Brush Cutters. Kamco is also trading various agricultural machineries and implements such as Mini Tractor, Power Weeders, Drones, Electric Brush Cutter, Coconut Climbers, Wheel barrows, Sprayers e.t.c. 2. PROCEDURE FOR REGISTRATION

KAMCO Limited hereby invites Expression of Interest (EOI) for supply of Petrol & Diesel Engines for various agricultural machineries such as Power tiller, Power reaper, Power weeder, Mini combined harvester e.t.c. from manufacturers / Traders/Importers as per the following procedures:

2.1. Interested suppliers need to be submit the EOI within the stipulated time.

2.2. Screening of EOIs will be as per the eligibility conditions contained herein based on documents submitted. After screening, the selected Manufacturers / Traders / Importers will be advised to submit supplier / vendor registration forms as per approved Format.

2.3. The suppliers / vendors will be evaluated based on the information given in the Supplier / Vendor registration form submitted by the supplier (which can be downloaded from the website attached to this EOI as Annexure.)

2.4. Supplier / Vendor Registration will be done based on the Evaluation Report.

Selected registered Suppliers / Vendors will be asked to submit minimum 1 sample free of cost to KAMCO for conducting 50 hrs field trials. On successful completion of trials, they will be asked to submit commercial & financial terms for trial order of 50-100 Nos as per requirement of KAMCO. On successful completion of trail order they will be eligible for regular orders placed through Tenders.

3. ELIGIBILITY CRITERIA/PRE-QUALIFICATION CRITERIA.

Vendor / Supplier Registration is sought from eligible manufacturers/traders / importers of engines as per KAMCO approved specifications.

The manufacturers /traders / importers or suppliers who express interest in supplying should meet the following minimum terms, conditions and criteria:-

1. The applicant should be a regular manufacturer/trader / importer / supplier of IC Engines.
2. The applicant should have sold minimum 500 Nos of Engines during the last 3 years.
3. The turnover of the applicant should be above Rupees.1 Crores or equivalent for at least two years in the last three years.
4. The applicant outside INDIA should be an exporter of the Engine. They have to mention the county of origin of the Manufacturer.
