Commodity EXIM Report DGCI & S, I T J Division

- 1. The weekly EXIM Report published by ITJ Division of DGCI&S, Kolkata presents some basic insights into India's export and import trade patterns with respect to selected set of commodities identified each week in order to facilitate preliminary commodity group/sector specific analysis for informed trade decision making.
- 2. For both categories of trades, one commodity group is chosen from the entire ITC-HS 4-digit Classification (latest being 2024 classification system). The Indian Trade Classification based on Harmonized System has been adopted in India for Export and Import Operations. While India specific data is sourced from DGCI&S, M/o C&I Database, global export-import data of exactly those sets of commodities are sourced from UN-COMTRADE Database.
- 3. As regards the time-period, this report outlines trade statistics over a period of four years, i.e, 2021 to 2024. The latest finalized data available on the UN Comtrade Database is only up to year 2024 (Calendar Year) and on the DGCI&S Database up to August, 2025. So, for each commodity group dealt in this report, trends from 2021 to 2024 have been showcased where data has been sourced from UN Comtrade and from DGCI&S database.
- 4. In the instant report [1st weekly Commodity Exim Report of November, 2025 dated 5th November, 2025] the following two commodities have been dealt with.

Export: Insecticides, Rodenticides, Fungicides, Herbicides, Anti-Sprouting Products and Plant-Growthregulators, Disinfectants and Similar Products [ITCHS Code –3808] -In the year 2024, this commodity group had 0.95% share in India's total Export value basket as per DGCI&S database. India occupied the 3rd slot in export of this commodity (exported 4141.82 million USD) with 10.05% share of total global exports in the year 2024.

Import: Dried Leguminous Vegetables, Shelled, Whether or not Skinned or Split [ITCHS Code – 0713] –In the year 2024, this commodity group had a share of 0.72% in India's total Import value basket as per DGCI&S database. India having 33.93% share of total global imports of this commodity (5061.16 million USD), occupied the top slot in the world in 2024.

EXPORT

Insecticides, Rodenticides, Fungicides, Herbicides, Anti-Sprouting Products and Plant-Growthregulators, Disinfectants and Similar Products. Classified as H.S. Code – 3808 falls under Chapter - 38 (Miscellaneous chemical products) of Section VI (Products of the Chemical or Allied Industries) of ITC-HS classification.

India is engaged in the process of exporting this commodity and in 2024 this commodity group had so far 0.95% share in India's total Export value basket as per DGCI&S database.






In the year 2024 India exported Insecticides, Rodenticides, Fungicides, Herbicides, Anti-Sprouting Products and Plant-Growth regulators, Disinfectants and Similar Products worth of USD 4207.14 million and registered a decrease of 2.72% compared to 2023 figures of USD 4324.79 million. Brazil (importing USD 1037.39 million worth of goods in this segment from India) held the top slot as an export destination in this segment with 24.66% share of India's total export in 2024. In second and third place were USA (USD 804.17 million) and Japan (USD 392.53 million) to where India exported around 19.11% and 9.33% of total Insecticides, Rodenticides, Fungicides, Herbicides etc respectively in 2024. Over the period under review exports of Insecticides, Rodenticides, Fungicides, Herbicides etc from India were at USD 4494.08 million in 2021 followed by a rise in 2022 and then turned to decrease in 2023 and 2024.



World's 10 leading exporters of Insecticides, Rodenticides, Fungicides, Herbicides etc (percentage share in 2024):\




The Insecticides, Rodenticides, Fungicides, Herbicides etc exports worldwide was USD 41211.58 million in 2024 with a decrease by 3.16% compared to 2023 levels. Over the period under review global exports were at record high at USD 48519.77 million in 2022. **India** (exporting goods worth a total of USD 4141.82 million in this category) with a show of 10.05% share, stood at 3rd slot globally. The lead exporters in this segment has persistently been China (exporting goods worth a total of USD 8995.42 million) and USA (USD 4830.22 million) with 21.83% and 11.72% share of world export in 2024 respectively. India's share in global exports of this commodity had gradually been downwards.



Top 10 importers of Insecticides, Rodenticides, Fungicides, Herbicides etc from 2021 to 2024 (Data labels signified for 2024)




World's 10 leading importers of Insecticides, Rodenticides, Fungicides, Herbicides etc (Percentage share in 2024)




The Insecticides, Rodenticides, Fungicides, Herbicides etc imports worldwide was USD 38177.20 million in 2024, decreased by 9.46% from 2023 levels. The lead importers in this segment in 2024 were Brazil (13.03%), France (5.43%) and Canada (4.84%). **India** with a show of 4.12% share in this category, stood at 5th position globally. Global imports in this segment increased in 2022 from 2021 level and then turned to decrease till 2024. India's imports in this segment decreased till 2023 and then increased in 2024. As per UN Comtrade database the top 3 importers of Insecticides, Rodenticides, Fungicides, Herbicides etc

As per UN Comtrade database the top 3 importers of Insecticides, Rodenticides, Fungicides, Herbicides etc were **Brazil**, **France and Canada**. These three countries had imported 9.39%, 0.70% and 1.92% share of their total import of this commodity from India in 2024 which are presented below:


(i) Top 3 supplier nations of Insecticides, Rodenticides, Fungicides, Herbicides etc to Brazil in 2024 (percentage share)

IMPORT

Dried Leguminous Vegetables, Shelled, Whether or not Skinned or Split as ITCHS Code – 0713 falls under Chapter -07 (Edible vegetables and certain roots and tubers) of Section – II (Vegetable Products) of ITC-HS Classification.

India is engaged in the process of importing this commodity and in the year 2024 this commodity group had share of 0.72% in India's total Import value basket as per DGCI&S database.

The total amount of India's import of Dried Leguminous Vegetables, Shelled, Whether or not Skinned or Split in 2024 stood at USD 5136.97 million, recording an increase of 66.70% compared to 2023 figures of USD 3081.54 million. In 2024, Myanmar stood out as the top importing partner in this segment from where India imported 23.59% share of its total imports of this commodity followed next by Canada (20.82%) and Australia (11.97%) respectively in 2024. India's import value in this segment decreased from USD 2095.32 million in 2021 to USD 1935.50 million in 2022 and then continued to increase till 2024.

Worldwide import of Dried Leguminous Vegetables, Shelled, Whether or not Skinned or Split totalled to USD 14914.54 million in 2024 with a little decrease of 2.80% over 2023 levels. **India** imported USD 5061.16 million worth of the commodity in 2024, making it the leading importer of the commodity group worldwide with 33.93% share of world imports. The import value of Dried Leguminous Vegetables, Shelled, Whether or not Skinned or Split in China amounted to approximately USD 1277.54 million in the year 2024 and ranked 2nd in the world with the share of 8.57% of total global import value of goods in this segment followed next by Turkey (6.66%). Over the period under review global import in this segment steadily increased till 2023 and then decreased in 2024.
